WHEREAS, Flock Group Inc., d/b/a Flock Safety, 1170 Howell Mill Road NW, Suite 210, Atlanta, GA 30318 offers a software and hardware solution for automatic license plate detection through Flock's technology platform, and upon detection, the Flock Service creates images and recordings and can provide notifications to the New Brunswick Police Department; and

WHEREAS, the Police Department has recommended the renewal of this Agreement in the amount of **Five Thousand Dollars (\$5,000.00)**; and

WHEREAS, funds are available for this purpose in the amount of **Five Thousand Dollars (\$5,000.00)** in **Account Number 01-213-41-240-622**; the signature of Richard Mulrine, Chief Financial Officer, on this Resolution certifying that such funds are available in the 2022 Municipal Budget.

NOW, THEREFORE, BE IT RESOLVED, by the New Brunswick City Council that the Mayor and City Clerk are hereby authorized to execute and attest the renewal of the Agreement for the Lease of a Pole Mounted License Plate Reader from Flock Group Inc, d/b/a Flock Safety for a term of twelve (12) months at a cost of **Five Thousand Dollars (\$5,000.00)**, the form of Agreement to be approved by the City Attorney; and
