Attached please find the probable cause statement in response to your request. Redactions have been made under N.J.S.A. 47:1A-1.1 – Personal Identifying Information and Privacy Interest.

Please be advised that the Investigation Report is being **Denied** pursuant to N.J.S.A. 47:1A-1.1 – Criminal Investigatory Records – records which are not required by law to be made, maintained or kept on file that are held by a law enforcement agency which pertain to any criminal investigation or related civil enforcement proceeding. (Note: N.J.S.A. 47:1A-3b lists specific criminal investigatory information which must be disclosed, which information, where applicable, is already included in the probable cause statement provided). This record is considered exempt.

Please be advised that the BWC footage and dash-cam footage is being **Denied** pursuant to N.J.S.A. 47:1A-3 – Ongoing Investigations – right of access may be denied where it can jeopardize an investigation in progress. 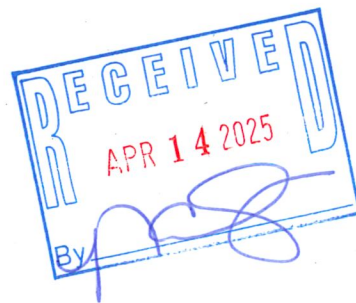

Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 11/24/24 at approximately 1118 hours, officers responded to 151 Cottage Ave. for a report of a gunshot victim. Upon arrival, officers located the victim, Kevon Williams, deceased with gunshot wound to the back of the head. Preliminary investigation and video surveillance from the area revealed James Snead, Jr. as the suspect shooter in the area. Snead, Jr. was seen getting into the front passenger side door of a gold-colored Ford Edge. Snead, Jr. then got out and pulled out a handgun and proceeded to shoot two rounds in the direction of the victim and another male. The victim was seen on video fall to the ground as the second victim ran north in the alleyway. The accused got into the vehicle and the female driver, who was later identified as R.S., was seen leaving the scene headed east on Cottage Ave. towards Atlantic St. R.S later came to the police department and provided a statement and identified the shooter as James Snead, Jr. R.S stated she attempted to have James turn himself in. However, he jumped out of her vehicle and fled the area on foot, which was also verified on video. A search for the accused is ongoing at the time this complaint was generated.
