windows being heavily tinted and the temporary registration being unclear due to lamination on it.

I joined traffic on 1&9 north and positioned my marked patrol vehicle behind the Acura. I further observed the Acura have defective brake lights, specifically by the rear passenger side and center brake lights not illuminating. I also observed the Acura conduct an improper lane change. I then activated my emergency lights and sirens to initiate a motor vehicle stop underneath the Lemoine Ave overpass. Police Officer J. Perez #338 responded as backup. I began speaking with the driver of the vehicle Ms. Joanny J. Garcia and requested her drivers license, registration and insurance to which she could only provide a picture of her driver's license. Officer Perez began speaking with the passenger, who was later identified as Ms. Girania Sanchez-Sosa.

Ms. Garcia stated they were traveling from North Carolina to Boston to drop off Ms. Sanchez-Sosa's step son. [REDACTED]

[REDACTED] At this time I requested Fort Lee Communications Center (Com-Cen) to dispatch a tow to impound the Acura. While Officer Perez was speaking with Ms. Sanchez-Sosa, she voluntarily provided her Puerto Rico drivers licence.

After checking Ms. Sanchez-Sosa's Puerto Rican drivers license through (NCIC), it yielded a return for an active warrant from Henrico County Virginia. I notified (Com-Cen) of the possible warrant and provided them with Ms. Sanchez-Sosa's information. Com-Cen searched for any active warrants for Ms. Sanchez-Sosa and was able to confirm a full extradition arrest warrant from Henrico County Virginia. Sergeant V. Triantafillou #237, Police Officer C. Bizub #328, and Police Officer M. Awad #342 then responded to the scene as back up.

Officer Perez advised Ms. Sanchez-Sosa that she was under arrest, at which point I secured Ms. Sanchez-Sosa in handcuffs which were double locked and checked for tightness. Officer Bizub searched Ms. Sanchez-Sosa for any weapons and contraband, yielding negative results. Ms. Sanchez-Sosa was escorted to the rear of marked unit #477, which I searched before and after transport with negative results for weapons or contraband.

At approximately 0449 hours, Ms. Sanchez-Sosa was transported to Bergen County Jail pending extradition to Virginia. The Acura was impounded [REDACTED]

Subsequent to the stop, the driver, Richard SANTANA-ROSA had two active warrants (E20-2657) from Perth Amboy Municipal Court for the full bail amount for \$750.00 and (E20-23776) from Elizabeth Municipal Court for the full bail amount of \$1,000.00. SANTANA-ROSA was arrested and transported back to Fort Lee Police Headquarters. I secured SANTANA-ROSA in handcuffs, which were double locked and checked for tightness. I transported SANTANA-ROSA in the rear of marked unit #469 which was searched for weapons and contraband before and after transport yielding negative results. At headquarters, SANTANA-ROSA posted the cash 10% bail amount of \$75.00 for Perth Amboy which was secured by Lieutenant R. Hernandez #250 in the secure bail collection box located at the front desk. I completed a New Jersey Bail Recognizance Form for SANTANA-ROSA and the warrant was executed by Dispatcher #59. The City of Elizabeth released SANTANA-ROSA on his own recognizance pending a new court date. SANTANA-ROSA was released from Headquarters without incident pending a new court appearance in Perth Amboy and Elizabeth. SANTANA-ROSA was issued a verbal warning for the motor vehicle violation.
