While traveling on Colonial Road, I observed a blue heavily tinted sedan pass my location with appeared to be a fictitious temporary registration and a third brake light out. I conducted a motor vehicle stop on NJ Rt 287 North along mile marker 61.6. The vehicle possessed a rear FL temporary registration DE157A9 with an expiration of 01/01/2025. I approached the passenger side of the vehicle and was met by lone driver and occupant, Duvly Simeon. Simeon was unable to provide any documentation for the vehicle and advised it was his brother's car. Simeon provided a NY driver's license which was discovered to be suspended.

Incident Report



On January 4th, 2024 while on stationary patrol, I observed a black Lincoln bearing Indiana registration "AST642" traveling West on Route 208 North with the passenger headlight out. I pulled out into traffic to approach the vehicle, when I observed the vehicle operate a lane change without using a turn signal. I attempted conduct a motor vehicle stop on Route 287 South near exit 58, but the vehicle took the exit, and stopped near Route 202. Due to the dangerous location where the vehicle stopped, I directed the driver to park in the Exxon Gas Station parking lot on Route 202, which he did without incident.

I exited my patrol unit and met with the driver. I advised the driver of why I conducted the motor vehicle stop, and requested his documents. I was provided with a New York driver's license, with a name of "Richard J. Kase", along with the registration card and an expired insurance card as of August of 2024. I inquired as to who's vehicle Mr. Kase is driving, to which he replied that it is his roommates vehicle who he resides with in New York. (PO Shutrop now on scene).

I re-entered my patrol unit and observed an Infocop ticket history for Mr. Kase, issued from the Chatham Police Department. I observed that the name on the ticket history was "Richard J. Esak" with the same date of birth and same NY driver's license number that I was provided. I then ran "Richard J. Kase" for outstanding warrants, and was met with negative results. I then immediately ran the name "Richard J. Esak" for warrants, to which I observed an outstanding traffic warrant (Warrant #: E24 5719) out of Madison Joint Municipal Court for \$750. The information on the outstanding warrant also had an identical NY driver's license number, along with the identical address and date of birth as Mr. Kase. I also located an NJ driver's license under the name of "Richard J. Esak" (DLN: [REDACTED]) which had Mr. Kase's same date of birth, and I positively identified "Richard J. Esak" to be Mr. Kase through the photo identification attached to his NJ driver's license.

I now requested Mr. Kase to step out of his vehicle to inquire about why he has two different names included in his history. Mr. Kase stated that he recently changed his last name from "Esak" to "Kase", but that he was born with the name of "Richard J. Esak." Mr. Kase explained that he changed his name due to wishing to be separated from his family due to personal problems. I now advised Mr. Kase that he has an outstanding warrant for his arrest under his prior name of "Esak" and that he is under arrest. I placed Mr. Kase in handcuffs, searched him incident to arrest, and seated him in the rear of marked unit 305. With Mr. Kase's permission, I retrieved his jacket, phone, wallet, and water bottle from the vehicle, and placed it in unit 305. I met with an Exxon employee who stated that the vehicle, which was legally parked in the Exxon Gas Station parking lot, may temporarily remain there. (No tow dispatched).

I then transported Mr. Kase to the Franklin Lakes Police Department, utilizing the vehicle camera of unit 305. While en route, I read Mr. Kase his Miranda Rights. While I was driving on Dekorte Drive approaching headquarters, I observed Mr. Kase fidgeting in the rear of my unit. I immediately parked the vehicle outside and opened the rear door of the vehicle to check on Mr. Kase's status. I observed Mr. Kase to have unbuckled his own seat belt and partially maneuvered his handcuffs under his legs and in front of his body. At this time, PO Shutrop accompanied me as Mr. Kase was escorted on foot through the sally port into the cell block of police headquarters. Once at police headquarters Mr. Kase was processed and photographed as per departmental policy. During processing, I read Mr. Kase his Miranda Rights a second time, but he refused to sign the Franklin Lakes Miranda Form. Chatham Police Department advised police dispatch that

they will release Mr. Kase on his own recognizance, providing an ROR Form with a court date of January 29th, 2025 at 14:00 hours (virtual). The ROR Form was signed by Mr. Kase and myself, and was sent back to Chatham Police. It shall be noted that Mr. Kase refused to sign the Franklin Lakes Property Receipt.

Upon releasing Mr. Kase, I provided him with a copy of the signed ROR Form. I safely provided Mr. Kase with a courtesy transport, utilizing the vehicle camera of 305, to his parked vehicle at Exxon Gas Station.

All necessary paperwork was placed in the appropriate bins within headquarters. The outstanding warrant was properly executed by Franklin Lakes dispatch.

Mr. Kase was issued three motor vehicle summons:

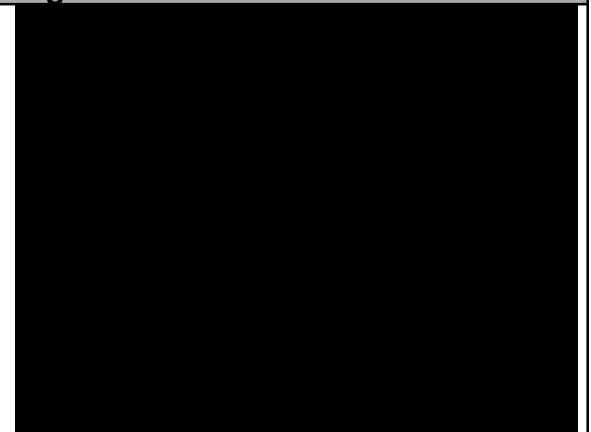
