Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On February 8, 2020 at approximately 1148 hours, the Howell Township Police Department (HTPD) received a 911 emergency call from the telephone number, [REDACTED]. HTPD Dispatcher, Thomas Ford, answered this 911 call. The male caller advised Dispatcher Ford that he observed a white van driving around in Point O Woods (Townhouse Development). The van had a male and female subject and a child. According to the caller, the occupants of the vehicle were waving a gun out of the window. The male caller advised Dispatcher Ford that he last saw the van on Sugar Maple Court. The male caller advised Dispatcher Ford that he has a picture of the van's license plate on his phone. The male caller provided Dispatcher Ford with the license plate number, [REDACTED]. New Jersey Division of Motor Vehicle (NJDMV) records indicate that the New Jersey registration, [REDACTED], belongs to a white in color 2009 Chrysler van registered to a Patrick Gleason of 251 Sugar Maple Court in Howell, NJ. NJDMV records indicate that Patrick Gleason is a 50-year-old white male who is 6'2" tall with blue eyes. As a result of the above 911-telephone call, multiple HTPD units were dispatched to the area of Sugar Maple Court. While enroute to the area, Patrolman William Bommer Jr., located a white in color Chrysler van bearing the New Jersey registration, [REDACTED] on Old Tavern Road in the area of the Howell Township Library (318 Old Tavern Road). Patrolman Bommer and other HTPD units conducted a felony motor vehicle stop upon this vehicle. After the felony motor vehicle stop was conducted, Patrolman Bommer was able to identify the occupants of the vehicle as Patrick Gleason (driver), Tina Gleason (49-year-old front seat passenger), K [REDACTED] G [REDACTED] (17-year-old back seat passenger), and C [REDACTED] G [REDACTED] (15-year-old back seat passenger). Tina and Patrick are a married couple. K [REDACTED] and C [REDACTED] are children of Tina and Patrick. It was learned by Ptl. Bommer and other HTPD units that the 911 call was clearly false. This information was obtained by speaking with the above vehicle occupants and multiple residents who reside on Sugar Maple Court. It was learned that the telephone number, [REDACTED], is a pre-paid Trac Fone. A CDW demanding call history for this wireless telephone number was obtained. I reviewed the call history and determined that the subject who placed this false 911 call was Frederick T. Esposito.

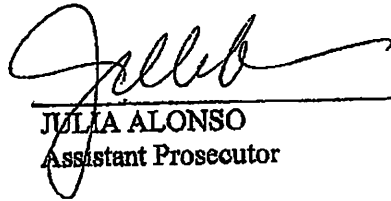
