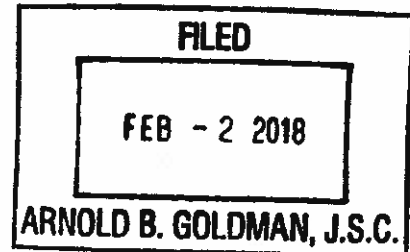

THIS MATTER having been brought before the Court upon the application of Richard

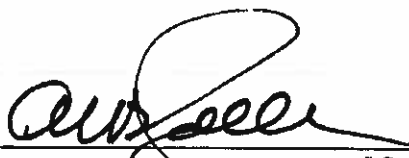

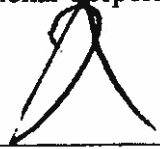

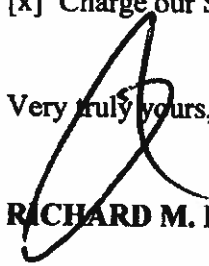
