**RESOLUTION ACCEPTING QUOTE AND AWARDING A CONTRACT/PURCHASE
ORDER TO ACE IRRIGATION LLC dba ROYAL IRRIGATION AND HOLIDAY
DECORATING OF NJ FOR A LED LIGHTED EDISON LIGHTBULB**

WHEREAS, a quote was solicited by the Township of Edison for the design and supply of a custom LED “Edison” lightbulb lighted sign; and

WHEREAS, ACE IRRIGATION LLC dba ROYAL IRRIGATION AND HOLIDAY DECORATING OF NJ, 8 Timber Lane, Marlboro, NJ 07746, submitted the lowest quote in the amount of \$18,600.00 plus freight (NTE \$1,000) for a total Not to Exceed amount of \$19,600.00; and

WHEREAS, this amount exceeds \$17,500.00 and therefore needs authorization through the provisions of N.J.S.A. 19:44A-20.5 et. seq.; and

WHEREAS, prior to entering into a purchase order/contract, the vendor will have completed and submitted a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the Township of Edison in the previous one year, and that the contract will prohibit the vendor from making any reportable contributions through the term of the contract; and

WHEREAS, funds in the amount of \$19,600.00 have been certified to be available in the Recreation-Equipment & Upgrades Account, number C-04-18-2028-104-000; and

WHEREAS, the Township Council accepts Edison Township’s recommendations as described herein.

NOW, THEREFORE, IT IS RESOLVED by the Township Council of the Township of Edison, as follows:

1. The quote has been reviewed, and the quote submitted by ACE IRRIGATION LLC dba ROYAL IRRIGATION AND HOLIDAY DECORATING OF NJ, 8 Timber Lane, Marlboro, NJ 07746, for the design and supply of custom LED lighted “Edison” lightbulb, is hereby approved.
2. The Mayor, or his designee, is hereby authorized to execute a contract/purchase order in the amount of \$19,600.00 and any other necessary documents, with ACE IRRIGATION LLC dba ROYAL IRRIGATION AND HOLIDAY DECORATING OF NJ, as described herein.
3. This contract is awarded pursuant to 19:44A-20.5 et. seq, and without competitive bidding.
4. The Business Disclosure Entity Certification and the Determination of Value shall be placed on file with this resolution.
