

RESOLUTION R.727-112022

RESOLUTION ACCEPTING QUOTE AND AWARDING A CONTRACT/PURCHASE ORDER TO PARTY JAM INC., FOR A SYNTHETIC ICE RINK FOR THE HOLIDAY MARKETPLACE

WHEREAS, quotes were solicited to rent a synthetic ice rink for the upcoming Holiday Marketplace; and

WHEREAS, PARTY JAM INC., 18 Hervey Street, Staten Island, NY 10309, submitted the lowest responsible and responsive quote for this in the amount of \$28,500.00 (\$9,500 per weekend; three (3) December weekends); and

WHEREAS, this amount exceeds \$17,500.00 and therefore needs authorization through the provisions of N.J.S.A. 19:44A-20.5 et. seq.; and

WHEREAS, funds in the amount of \$28,500.00 is available in the Reserve for Winter Events Trust Account, number T-13-00-0000-000-038; and

WHEREAS, prior to entering into a purchase order/contract, the vendor will have completed and submitted a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the Township of Edison in the previous one year, and that the contract will prohibit the vendor from making any reportable contributions through the term of the contract; and

WHEREAS, the Township Council accepts Edison Township's recommendations as described herein.

NOW, THEREFORE, IT IS RESOLVED by the Township Council of the Township of Edison, as follows:

1. Quotes have been reviewed, and the quote submitted by PARTY JAM INC., 18 Hervey Street, Staten Island, NY 10309, for the rental of a synthetic ice rink for the upcoming Holiday Marketplace, is determined to be the lowest responsible and responsive quote.
2. The Mayor, or his designee, is hereby authorized to execute a contract/purchase order in the amount of \$28,500.00 and any other necessary documents, with PARTY JAM INC., as described herein.
3. This contract is awarded pursuant to 19:44A-20.5 et. seq, and N.J.S.A. 40:11-11 et seq.
4. The Business Disclosure Entity Certification and the Determination of Value shall be placed on file with this resolution.

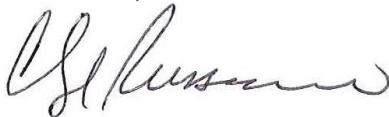
