It is agreed between the Board of Education of the **HAMILTON TOWNSHIP SCHOOL DISTRICT** in the County of **MERCER** party of the first part, and **GLEN FLEMING**, party of the second part, that said Board of Education has employed and does hereby engage and employ the said party of the second part as a **Teacher BA Hamilton High School West**** in the public schools under the control of said Board of Education, from the **1st** day of **SEPTEMBER 2024** to the **30TH** day of **JUNE 2025** at the salary rate of **\$88,569.00 or the 24-25 step upon agreement with the HTEA** per year, to be paid in equal semi-monthly installments. The party of the second part continues to hold an appropriate certificate issued in the State of New Jersey that continues in full force and effect, and will exhibit the certificate to the Superintendent or designee of the district in which such school is situate at the discretion of the Superintendent or designee.

The said party of the second part hereby accepts the employment aforesaid and agrees to faithfully do and perform duties under the employment aforesaid, and to observe and enforce the rules prescribed for the government of the school by the Board of Education.

It is hereby agreed by the parties hereto that this contract may at any time be terminated for cause by the party of the first part in accordance with statute. The party of the second part may terminate this contract with **SIXTY (60)** days' notice in writing of intention to terminate the same, but that in the absence of any provision herein for a definite number of days' notice, the contract shall run for the full term named above. Employment is contingent upon the party of the second part continuing to satisfy all of the requirements for employment in a public school district in New Jersey.

This reappointment was approved at the regular monthly meeting of the Hamilton Township Board of Education, held on May 22, 2024.
