"The Atlantic County Prosecutor's Office has become aware of an incident that was reported early Sunday morning that occurred at the Golden Nugget Hotel & Casino, 600 Huron Ave, Atlantic City, involving Atlantic City Mayor Frank Gilliam, Atlantic City Councilman Jeffree Fauntleroy II, and three other individuals. The matter is currently being reviewed by the Atlantic County Prosecutor's Office. We have no further comment at this time," Atlantic County First Assistant Prosecutor Cary Shill said.

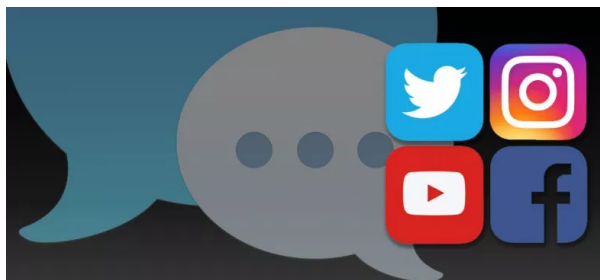
