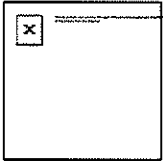

- 2) ALL RECORDS IN THE POSSESSION OF THE HALEDON POLICE DEPARTMENT MENTIONING OR RELATED TO ASLON GOOW, INCLUDING BUT NOT LIMITED TO POLICE REPORT AND HALEDON PD WRITTEN COMMUNICATIONS

The records are being transmitted to you via . Pursuant to N.J.S.A. 47:1A-5.b. the cost associated with this request is **\$0.00**.

You have a right to challenge the decision by Borough of Haledon to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.

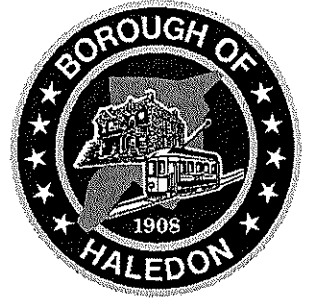
