Your application for your appeal must be in writing, stating your name and address, the address of the violation, the specific reason for your appeal and the nature of the relief sought by you. Forward to Construction Board of Appeals, PO Box 719, New Road & Dolphin Ave, Northfield, NJ 08225. The fee for an appeal is \$100. to be forwarded with your application.

When work to abate the violations requires a construction permit, the owner is responsible for securing such a permit. Maintenance violation (Part 12) can be found in the newest adopted code.
