Forward to Construction Board of Appeals, PO Box 719, New Road & Dolphin Ave, Northfield, NJ 08225. The fee for an appeal is \$100. to be forwarded with your application.

When work to abate the violations requires a construction permit, the owner is responsible for securing such a permit. Maintenance violation (Part 12) can be found in the newest adopted code.
