On the above date and time, I, Officer R. Sime 884 along with my Partner M. Toto #5299, was in a uniformed capacity designated as Charlie 6Fox. We were assigned to the Charlie Patrol Division of the Atlantic City Police Department with a tour of duty from 2300-0700 hours. I was driving a marked police patrol vehicle designated Charlie 7.

While on roving patrol we received a dispatched call to the above location, in reference to a brawl in the valet area, from security an unknown male is unconscious. Upon our arrival security stated the group that was in the brawl separated. No one knew who initiated the fight. While talking with security I noticed a male being place on an ambulance stretcher, I immediately turned my attention to the unknown male victim who appeared to be covered in blood to the facial area. Due to the face being covered in blood I was unable to obtain information from him on scene. I asked Harrah's security personnel if they are pursuing criminal complaints against anyone that was involved in the brawl and security stated, "no."

I went to the AtlantiCare Medical regional center. There I was able to speak with the male victim identified as [REDACTED]. [REDACTED] stated he did not know who assaulted him nor how the fight started. I asked [REDACTED] if he would like to pursue a criminal complaint against whoever assaulted him if Harrah's located a suspect. [REDACTED] stated that he did want to sign a complaint for the assault if the assailant was located. [REDACTED] was provided a case number, additional information pending regarding the suspect (s).

In this case the complainant is unable to sign a complaint until the identity of the suspect(s) is determined.
