8-17-22, ONSITE FOR FOLLOW UP. , THERE ARE NO CHANGES TO THE CONDITIONS OF THE REST ROOM AREA. A CHAPTER 24 INSPECTION WAS PERFORMED, WHICH RESULTED IN A CONDITIONALLY SATISFACTORY RATING.

8-22-22, I SPOKE WITH GINA BRITTON, DISTRICT MANAGER, I INFORMED HER OF THE CONDITIONS OF THE ESTABLISHMENT AND THE FACT THAT THERE WAS NO EFFORT TO CORRECT THE ISSUES BY MANAGEMENT.
