My husband and I have lived at 3 Cabot Court in Marlton (The Meadows) for 33 years and our backyard backs up to a very small open space (the wetlands) with Cabot Court on one side and Shamrock Lane on the other. For 33 years my husband has graciously mowed the grass there. This past summer, with one of the strong storms we had, caused my neighbor (on Shamrock Lane) to have a couple of large tree limbs fall onto the open space. We're not sure if he's aware of this. The tree limbs are too big for my husband to move, hence they are still laying there and the grass has grown on top of and around them. This is not only unsightly, but now there's an odor.

I was told Kevin was on vacation for a week, then he was working from home the following week, still no response.
