Good afternoon [REDACTED]

My husband, and our two small children were displaced from our home due to arson. We have been staying at the Residence Inn in Cherry Hill since the event. Our bill there is \$3000.

We recently signed a new rental contract and will have the keys for it this Saturday. The security deposit and one month of rent is \$6500.

As you might imagine the unexpected expenses are quite high. We have spent over \$10,000 in the first one week.

While we are extra fortunate to have received the overwhelming support of our community, we still struggle to ensure our family has everything they need.

The new path of recovery is being able to also furnish the home with the basic items.

I am reaching out for support. Is there any special funds that could be afforded to us as a way to offset these unexpected expenses?

Thank you councilwoman Cooper for connecting us.
