Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On June 24, 2020, a fraud report was made to the Pemberton Township Police Department by a female subject identified as [REDACTED]. [REDACTED] also reported the incident to the Burlington County Prosecutor's Office (Financial Crimes Unit), who then contacted me to advise me of the report.

During my investigation, [REDACTED] stated that [REDACTED] and [REDACTED] recently adopted a four (4) year old male subject identified as [REDACTED] from the defendant identified as Holly Garcia. [REDACTED] indicated that [REDACTED] and [REDACTED] went through various court proceedings with Garcia until she (Garcia) ultimately signed over her parental rights of [REDACTED] to [REDACTED]. Additionally, it was found that [REDACTED] was advised by a close friend that Garcia had created a Go FundMe campaign attempting to raise \$5,000 for [REDACTED] funeral costs.

Garcia detailed in the campaign that [REDACTED] had suffered from cancer and ultimately lost his life to the illness. Garcia attached a photograph of [REDACTED] to the campaign. [REDACTED] observed the campaign and knew that Garcia was attempting to raise funds for a fraudulent purpose since [REDACTED] is alive and healthy. Upon further investigation, it was found that Garcia also created five (5) additional campaigns on Go FundMe attempting to raise funds for living expenses, a vase for her deceased premature son's ashes, and a stroller for that premature baby who she previously indicated was deceased. [REDACTED] stated that Garcia did not have any other children. The various created campaigns totaled a value of \$11,350 in U.S currency. Garcia provided multiple email addresses for the campaigns which were later found to be created by her.
