

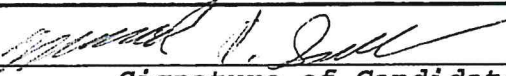
MUNICIPAL ELECTION - MAY 8, 2018

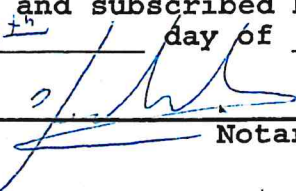

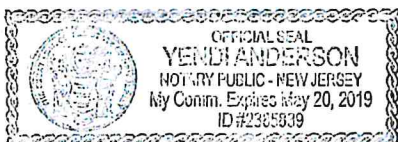
