Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On Monday, September 3, 2018 Detective Anthony Lacher posted an ad on Doublelist with the title "At my shore house for the week (Toms River)" with body text that read "down at my shore house for the week.. looking to meet new friends!" He received a response from the e-mail address [REDACTED] with an attached photo of a white male whom he recognized as Howell Police Department Officer Richard Conte. Detective Lacher informed him that he was a 15 year old female. [REDACTED] instructed Detective Lacher to claim that he was 18 years old if anyone asked his age and to download the application Kik to continue chatting. Detective Lacher created the account "lovotorun144" with a name of "Taylor LaConte." He instructed Detective Lacher through e-mail to enter an Ocean County Room on Kik and then messaged him from the user account "The Noble Crusader" with the vanity name "Ray Crusader." He then again asked the age to which Detective Lacher responded "15," and which he responded that he had already told Detective Lacher to say 18. Detective Lacher then turned this case over to Detective Lenart. Detective Lenart continued to chat with "Ray Crusader" on Kik. He expressed wanting to meet on Wednesday, September 5, 2018. Detective Lenart did not set up a meeting at that time. On September 6, 2018 "Ray Crusader" changed his story to indicate that he was 19 years old and had dated underage girls to include having sex with them. He said he would come to meet Detective Lenart and when she asked what he wanted to do when they met he said "get naked." They arranged to meet around 7 that night. Richard Conte showed up to the meet in his personal vehicle and drove off. He was later stopped in Seaside by Toms River Police Department and placed under arrest. He had condoms in his pocket at the time of arrest. Earlier on September 6, 2018 Detective Sergeant Richard Bruccoliere served a subpoena duces tecum to Kik for subscriber information for "The Noble Crusader." Kik responded with IP address logs. One of the IP addresses used to log in to the Kik account was registered to Richard Conte at his home address.

It is, therefore, on 08/25/2023 **ORDERED and ADJUDGED** that the defendant is sentenced as follows:
 Count 2 Amended: Defendant is sentenced to Probation for a period of eighteen (18) months with the following conditions: the defendant is sentenced to the custody of the Warden of the Ocean County Department of Corrections for a period of six (6) days as a condition of Probation and is credited with six (6) days of time served.
