UPON APPROACHING THE DRIVERS SIDE WINDOW I MADE CONTACT WITH THE OPERATOR OF THE VEHICLE IDENTIFIED PER HIS NJ DL AS IAN SMITH. I COULD IMMEDIATELY DETECT AN ODOR OF ALCOHOLIC BEVERAGE ON MR. SMITH AND OBSERVED HIS EYES BEING BLOODSHOT AND WATERY. MR. SMITH DID ADVISED HE HAD A DRINK AT A BAR IN COLLINGSWOOD AND WAS DRIVING TO DELANCO. I CONDUCTED SFST'S ON MR. SMITH TO WHICH HE FAILED. HE WAS TAKEN INTO CUSTODY AND BROUGHT BACK TO POLICE HEADQUARTERS WHERE HE REFUSED TO PROVIDE BREATH SAMPLES. MR.
