- o are parents of students receiving special education services at the elementary school level in a public school in the State;
- o are parents of students receiving special education services at the middle school level in a public school in the State;
- o are parents of students receiving special education services at the high school level in a public school in the State;
- o have expertise working with, or representing, students with disabilities;
- o have expertise working with, or representing, students with disabilities, and who have direct experience working with Black, Latino, and immigrant students with disabilities;
- o have expertise working with, or representing, students with disabilities, and who have direct experience providing transition services;
- o have expertise working with, or representing, students with disabilities and who are at least 21 years of age and have received special education and related services pursuant to an IEP;
- o are part of a child study team in a public school in the State;
- o are employed as a school psychologist;
- o are employed as a school social worker;
- o are employed as a learning disabilities teaching consultant;
- o are employed as a speech-language specialist.

3) Report of each of the above appointments submitted by the Commissioner to the State Board of Education pursuant to N.J.A.C 6A:2-2.2.
