I spoke with the accused / arrested, [redacted] who advised that [redacted] had left the store with non purchased items to retrieve something from [redacted] vehicle, and stated it was a misunderstanding. It should be noted that I did not ask [redacted] any questions pertaining to the event in question and the subject provided this statement under [redacted] own will. Based upon the surveillance video [redacted] was placed under arrest for shoplifting (2C:20-11(B) 1). Same would be transported to Aberdeen Township Police Headquarters without issue, processed and released on Summons ([redacted]). Same also received a no trespass order from Shop Rite advising [redacted] was barred from the store before being detained. Ptl. [redacted] would drive [redacted] back to [redacted] vehicle at Shop Rite to retrieve [redacted] vehicle without incident.
