On 10/15/2018 at 1643 hrs Ptl. Miller #218 and I responded to the area of 1612 Fort Street in reference to a suspicious vehicle. Upon arrival I spoke with the caller, Quincy T. Patterson.

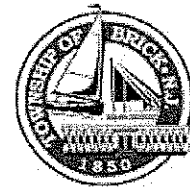
Quincy advised me that between 1600-1620 hrs several vehicles unknown to the area (white older model Jeep Cherokee, red Cadillac CTS and a black Nissan Altima - NJ registration #L79KMS) drove up and down the street several times. I observed video surveillance that Quincy possessed which showed at 1607 hrs 3 subjects getting out of the Altima and walking onto his neighbors front yard at 1614 Fort Street. Moments later they got back into their vehicle and drove away.

A short time later the white Cherokee and black Altima parked on Fort Street while the red Cadillac CTS parked on the corner of West Princeton Ave. The white Cherokee then backed up in the street lining up with the trailer in the driveway of 1614 Fort Street at which point Quincy walked out to the street. At that time all three vehicles left the area. No subject got out of the Cherokee while it had backed up in the street in line with the trailer.

Quincy was able to connect me on the phone with the homeowner of [REDACTED] Fort Street, Rosario Lamantia ([REDACTED]). Upon speaking to Rosario he stated that he did not believe he knew anyone that drove those kinds of vehicles. A check of the area was negative for any of the suspicious vehicles.
