On February 9, 2019 at 9:30 AM, I responded to 4514 Windsor Regency in regards to a hit and run motor vehicle crash.

Upon arrival, I spoke with the owner of V#2, who reported that she returned home at approximately 6:00 AM and did not observe any damage to V#2, which was parked overnight in its current parking space. The owner of V#2 explained that she spoke with a neighbor, who heard what sounded like a motor vehicle crash at approximately 8:00 AM and found V#2 with front end damage. I observed V#2, which sustained a broken front bumper, broken driver's side headlight and driver's side quarter panel damage as a result of the crash. The owner of V#2 could not provide any suspect vehicle and no one in the area observed the crash occur. I provided her with a case number for the incident and she was advised to contact me should she require any further information.
