On 06/26/2017 at 1944 hours, Ms. Sonia Ordonez responded to police headquarters to provide information related to parking at Windsor Regency. Ms. Ordonez explained that her vehicle was recently towed by Charlie Allen Towing for being improperly parked. She added that her vehicle was parked in the lot of her building and that the car was touching the yellow line marking the space and was subsequently towed for being outside of the single space. The cost of getting her vehicle back from the tow company exceeded \$200.00.

Ms. Ordonez explained that Charlie Allen towing has an exclusive contract with Windsor Regency to tow improperly parked vehicles. The vehicle are seemingly towed at will and at the discretion of the tow truck driver. The tow is not a result of a specific complaint from a resident or management or a summons issued by the police. Ms. Ordonez feels that this is a "money grab" by the towing company. Specifically, the majority of the towing occurs on Friday and Saturday nights and then the tow company holds the car until Monday so they can charge storage fees in addition to the towing fee.

Ms. Ordonez attempted to talk to the association and management about the matter, but they were less than helpful. She added that the residents are being taken advantage of and that the tow company has no right to decide who is violating the parking policy and who is not.

I attempted to contact the management office but they were closed and I had to leave a message. I will attempt to follow up upon my return to work. No further involvement at this time.
