On 12/10/2016 at 2044 hours, I responded to 41 Ivy Lane West for a report of found firearms belonging to the caller's estranged husband. Upon arrival I met with Ms. Kristin Skinner who explained the following information to me.

Ms. Skinner advised that she was looking for an unrelated item in the guest bedroom closet when she came upon a shoe box with guns in it. Adjacent to the guns was another box containing ammunition. She added she is estranged from her husband, who is a gun owner, but these items were not familiar to her. Ms. Skinner presented the box to me to examine the guns.

Upon opening the box, I was able to immediately identify the guns as imitation pieces. They were CO2 powered BB guns that are commonly sold in sporting goods stores. In the second box was CO2 cartridges and a bag of BBs. I explained to Ms. Skinner the difference between these items and a true firearm and she advised that she no longer wanted them removed from the house by the police. She explained that she would contact her lawyer on Monday to send a message to her estranged husband to have him come pick them up.

The items were returned to the top shelf of the closet so they would not be accessible to the small children living in the house. Ms. Skinner was advised to contact this agency at any time if she changes her mind and wants the items secured. No further police involvement.
