SUSPECT(S): Unknown

ATTACHED: Identity Theft Consent Document

At approximately 2020 hrs on Monday, December 20, 2010 I responded to 8 Swan Blvd for a possible fraud/theft of identity. Upon arrival I spoke with the victim, Jennifer Clarici, who stated that she had given her social security number to a female over the phone earlier today and believes that I may be a scam. Jennifer stated that she had received a call on both her house and cell phones from an unknown number at 1428 hrs and 1433 hrs respectively. Upon calling the number back she spoke with an unidentified female claiming that she and her company were affiliated with several banks and asked if she could be of any help. According to Jennifer, she is in the process of refinancing the house and believed that this call was somehow related.

At some point during the conversation, Jennifer stated that she was working with TD Bank and ultimately provided the female with her SSN. Shortly thereafter the conversation ended without any information/assistance provided. At no time during the conversation did the female identify herself or her company. In an attempt to prevent any negative financial consequences from her utterance, Jennifer contacted TD Bank and alerted them of the situation and cancelled, or was in the process of canceling, all of her credit cards. She also enrolled in the services of an online fraud protection service and was in the process of reporting the incident to the three credit bureaus. Coincidentally, at 1429 hrs Jennifer's husband received an e-mail from their loan officer regarding their closing and are unsure at this point if the phone calls were related (they were going to follow up with him in the morning).

In an attempt to identify the caller, I dialed the aforementioned telephone number which went directly to a voice mail system. No company or bank was identified but there were messages indicating that the "company" was somehow involved in the credit / finance business.

As a result of this incident, Jennifer was entered NCIC as a victim of identity theft under teletype 580 by TRPD Communications Officer Guichard #605.

Jennifer was provided with a report information card for the incident and advised to contact us should she have any further information.
