Narrative

On 7/26/2022 at 1335 hours I responded to the Lakewood Township Municipal lot between 2nd Street and 1st Street in reference to a Simple Assault. Upon my arrival, I met with the victim, identified as 22yo Daniel Mendez. Daniel who only speaks Spanish advised Spanish speaking Officer Delvalle #293 that he approached his boss in the lot and asked for money owed. His boss (unknown name) who he described as a "Mexican" male wearing black shorts and a white T-shirt said "I don't owe you anything" and then punched Mendez in the face. His boss then lifted the right side of his T-shirt and displayed a black and white knife attached to his belt. He then lifted the knife approximately one inch from a knife sheath and then lowered it back down. According to the victim, the suspect never verbally or physically threatened to use the knife.

Mendez stated the suspect was with another "Mexican" male (unknown name and description) who also had a black and white knife attached to his belt. That individual did not make any verbal or physical threats.
