Supplement

On the above date and time I, Sgt. Mayberry, responded to the area of Webster Avenue and the Boardwalk for a reported disturbance. Upon arrival, all parties were being dispersed by other officers. At some point after my arrival, I witnessed multiple officers running north bound on the boardwalk and proceeded to follow.

As I approached, I witnessed multiple officers (including Seaside Heights Officer Siino) attempted to place a male (later identified as Mavroidis M. Ioannidis) in handcuffs. I subsequently assisted and was able to place him in handcuffs without incident.

I later spoke with Officer Siino who relayed the facts of the incident. She stated that while officers were investigating the disturbance, she witnessed Mr. Ionnidis approach and begin throwing slices of pizza at responding officers. Officer Siino ordered him to stop at which time he attempted to flee on foot north on the boardwalk. Officer Siino (as well as multiple other officers including myself) subsequently caught up to the subject and placed him under arrest without further incident. See Officer Siino's Supplemental Investigation Report for further details.

After speaking with Officer Siino, I later authorized the charges of Disorderly Conduct (2C:33-2A(1) and Resisting Arrest (2C:29-2A(1) - Summons # 1526-S-2022-000292. He was transported to Police Headquarters, charged with the aforementioned offenses and later released with a pending court date.

BWC footage was reviewed prior to writing this report.

Supplement

On the above date and time while on boardwalk patrol I, Officer Siino, noticed a male party actively throwing slices of pizza at officers who were dealing with a disturbance call on Webster and the street end. Some slices had landed on parked cars on Webster and the street end.

I approached the male, (later identified as Mavroidis M. Ioannidis) identified myself as an officer and instructed him to stop throwing the pizza. At this point, the male had attempted to flee on foot heading north on the boardwalk. Myself and several other officers had caught up to the male on foot and were able to place him in handcuffs without further incident. Once placed in handcuffs, the male apologized to myself for throwing the pizza and then running.
