Upon arrival, I met with homeowner, Keith Salnick, who reported he spoke with "Mike" from the Oceanport Fire Department yesterday who advised he can make a fire in his yard as long as he dug a 3-4 foot hole. The hole was about 4 feet deep and approximately 8 feet wide, full of old lumber burning.

The wind was blowing east at the time directly towards the residence under construction. Chief Sherman arrived on location and advised the homeowner the FD will be responding to extinguish the fire that it is not permitted. OPFD did not respond, so LBFD Union Ave Co. responded and extinguished the fire. Homeowner was advised not to make another fire again. Cleared without incident.
