Narrative

Patrols responded to 60 Shore Rd for a complaint of loud music. Upon arrival, patrols observed all the windows of the residence to be open with loud music coming from the stereo system. It should be noted that the music could be heard from down the street of the residence. No contact was made at the residence. Patrols then attempted to contact the resident, Keith Salnick, via cell phone multiple times but were unsuccessful.

I then attempted an attached phone number to Salnick in spillman and was able to contact a family member who stated that her brother would be arriving shortly to the residence. While issuing Salnick a summons for loud music (274-1B), Ptl. Weir observed someone walking inside the residence through the front window. Patrols then approached the front door of the residence and made contact with Salnick, who appeared highly intoxicated.

Salnick pretended like he could not hear patrols and was very uncooperative. Patrols advised that we would be issuing him a summons for the loud music. While Ptl. Weir walked away from the front door, Salnick increased the volume of the music again after being told multiple times to lower the music.

At this time, Thomas D'Ambrisi arrived on location and Keith was left in his care. Keith was issued summons #1338SC006011 (B.O 267-1B) for loud music and handed the same.
