On Wednesday, November 24 2021, at approximately 2244 hours, I, Patrolman Murphy # 322 was patrolling the area of Mantoloking Road. While patrolling the area, I observed a 2006 Silver Ford 500 traveling south on Mantoloking Road. While behind the above vehicle I observed the driver, later identified as Keith Murphy, drifting to the left side of the lane and cross the centerline of the road then begin drifting towards the right side and crossing the white painted line onto the shoulder. I observed Murphy then turn onto Laurel Avenue and continue in the direction of Drum Point Road. While operating his vehicle on Laurel Avenue, I again observed Murphy fail to maintain the lane of travel, almost striking several parked vehicles, in violation of N.S.A 39:4-88b.

I activated the emergency lights on my marked patrol vehicle and initiated a traffic stop near 374 Cherry Quay Road. Upon making contact with Murphy, I introduced myself, the department, and advised Murphy for the reason of the stop. While speaking with Murphy, I recognized the overwhelming smell of alcoholic beverages emanating from the interior of the vehicle. I advised Murphy to provide his driver's license, the vehicle's registration, and proof of insurance. Murphy was [REDACTED] as he attempted to located his paperwork. Murphy provided the registration for the vehicle, put his hand into his front pockets then lifted himself to reach into his back pockets. After sitting back down into the seat, Murphy asked me what he was looking for. I again advised Murphy he needed to provide his driver's license and proof of insurance. Murphy then fumbled through several cards in his wallet before providing me with his driver's license and insurance card. While speaking with Murphy, [REDACTED]

[REDACTED]. Murphy at first advised that he was coming from his house on Lamb Street and he was on his way to see his girlfriend who lived on Cherry Quay Road. Murphy then reversed his story and stated his girlfriend lived on Lamb Street and he was on his way home to his house on Cherry Quay Road. I observed the address on his driver's license was [REDACTED], when asked again he advised that he does not live there his girlfriend does. Murphy advised that he had been drinking and had consumed four beers. Patrolman Catalina # 263 then arrived on scene to assist.

I advised Murphy to step out of the vehicle to conduct field sobriety testing. As Murphy stepped from his vehicle he stumbled and grabbed onto the door to maintain his balance.

At Headquarters, Murphy was escorted into the booking room for processing where he was screened for suicidal tendencies per departmental policy by SLEO I Lopez #141.

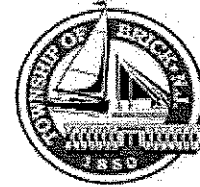
While in the booking room, Murphy was under SLEO I Lopez and my direct, uninterrupted, observation in excess of twenty minutes. On 11/21/2021 at approximately 1554 hours Ptl. Nelson #192, Ptl. Bajor #305 and I (Ptl. Pagnotta #301) responded to 217 Cherry Quay Road for a report of a motor vehicle accident.

Upon arrival I observed 2 women in the driveway of 210 Cherry Quay Road arguing and yelling. After separating both parties I spoke with Michele Dreyer who advised she was operating her vehicle, 2017 BMW, and crashed into a vehicle which was parked at 210 Cherry Quay Road. Dreyer advised she was coming from Beacon 70 and headed to her boyfriend's house in the area. Dreyer stated she was driving approximately 45 miles per hour and was text messaging when she lost control of her vehicle around a curve in the road and drove off the roadway.

Dreyer exited the roadway at 214 Cherry Quay Road and traveled across the lawn of 212 Cherry Quay Road ultimately crashing into a vehicle and basketball hoop located at 210 Cherry Quay Road (see Ptl. Nelson #192 crash report with the same case number for further details). Many neighbors and passing citizens stopped and advised officers they believed Dreyer was intoxicated. Anonymous citizens advised they observed the vehicle traveling at a high rate of speed prior to the vehicle crashing. Dreyer advised officers she was not intoxicated and was only texting on her phone prior to losing control of her vehicle. EMS responded as a precaution due to the severity of the collision. [REDACTED] and was run through standardized field sobriety tests due to the allegations of intoxication. Prior to conducting the sobriety tests Dreyer was transported by EMS to a safe location around the corner from the crash scene due to the large crowd and unsafe road conditions. Ptl. Bajor and I conducted all standardized field sobriety tests on Tiller Lane near the crash scene.

I explained and demonstrated the one leg stand to Dreyer who advised she understood the instructions. Prior to beginning the one leg stand I asked Dreyer if she suffered any injuries from the collision and she advised [REDACTED]

I then explained and demonstrated the walk and turn test to Dreyer who advised she understood the instructions prior to beginning. [REDACTED]

Dreyer was subsequently placed under arrest for suspicion of driving while intoxicated. She was handcuffed utilizing the double lock mechanism and searched yielding negative results. Dreyer was transported to police headquarters where she was booked and processed according to department policy. Ptl. Melia #267 responded to police headquarters and conducted the alco-test which returned a result of . [REDACTED] (see Ptl. Melia's

On 11/21/21 at approximately 1720 hours I responded to headquarters, 401 Chambers Bridge Rd., in order to operate the Alco-Test MK7110 for Ptl. Pagnotta's DWI arrest, see her case report for further information.

Upon arrival I secured my duty weapon and taser in the designated gun lock box. I entered the booking room and met with, Michele Dreyer and began the 20 minute face to face observation period which was constant and uninterrupted. I checked the interior of Dreyer's mouth which was negative for any findings. I read Dreyer her Miranda Rights as well as the NJ Standard Statement Form (implied consent). Dreyer advised she understood her rights and signed indicating the same. Dreyer also advised she would provide samples of her breath for testing. At the conclusion of the 20 minute face to face observation period, which was in excess of 20 minutes, Dreyer did not [REDACTED]. All electronic devices were removed from the booking area including all cell phones, portable radios, smart watches and portable lap top. I collected a total of five samples from Dreyer, utilizing five separate mouth pieces, which resulted in a [REDACTED]. During the first three attempts, Dreyer would begin to blow and immediately stop resulting in minimum volume not being achieved. On the last two attempts Dreyer provided two adequate samples. Brick Police Dispatch checked the Alco-Test results utilizing the NJ State Police Alco-Test Calculator which found the test results to be within acceptable tolerances.

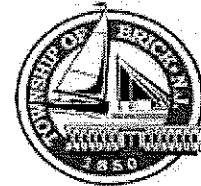

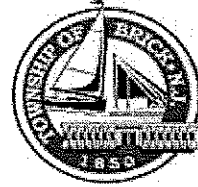

Kevin Ryan #306 and Ptl. Morgan Murphy #322, both were the initial responding officers, I learned the following.

Murphy arrived first and was met outside the residence by the caller, [REDACTED]. As he entered the small garage apartment, he found Bauman laying in the bed on her left side. She was [REDACTED]. He noticed that she was wearing a night gown and [REDACTED]. Additionally he noticed an opened bag of what appeared to be [REDACTED] near her knee on the bed that still had [REDACTED].

[REDACTED] reported to officers that he lives in the garage apartment alone and it is attached to his mother's house which has no interior access between the two. He said that he met Amber on Facebook about a week ago and that she has been staying at his residence for the last two days. Two days ago, Amber asked him to reach out to her "drug dealer" via Facebook Messenger from her phone. The dealers name was Mel. He said that he had contacted her and she delivered 2 bundles of heroin to his neighborhood. He and Amber walked down the street and met Mel to make the drug deal. He did not know Mel before this meeting and has no information about her besides her going by the name Mel.

The Ocean County Medical Examiner, Dr. Larkin, arrived on scene as well as Ocean County Sheriff CSI Officer Joseph Chester #222 and Brick Police Detective Matthew Fernino #283. As they processed the scene, they recovered and seized some suspect heroin as well as Bauman and [REDACTED] cell phones (see their reports for further information).

After the scene was processed, Amber was [REDACTED] by Chester, who then contacted Colonial Funeral Home to transport the body to Community Medical Center for Dr. Larkin. Colonial Funeral Home staff arrived and took possession of Amber. The scene was cleared and a crime scene report was completed by Ptl. John Canterelli #312.

[REDACTED] was given information for the Blue Hart Program, which he said he was already familiar with.

I then responded to 759 Sycamore Drive along with Ptl. James Albanese #257 in an attempt to notify Bauman's family. The door was answered by [REDACTED] and after I introduced myself and requested to come in the house to speak with her, she advised me that she had a daughter Amber. I confirmed that she was not alone at the house and her husband and two adult sons were upstairs. After sitting with her on the living room couch, I explained why we were there and the details about how Bauman was found earlier. After a period of time, [REDACTED] said that she has had many nights where she anticipated police arriving to give her the news of her daughters death. She inquired about a guy named, "Chuck", who she met with Amber earlier in the week. I acknowledged that the male subject who was with her was a man named [REDACTED]. I also provided her with the Ocean County Medical Examiners number as well as Fernino's name and the police department number. We stayed with the family for a short time but answered any and all questioned we could at that time for the [REDACTED]'s and additionally explained the process moving forward for the investigation and the release of Bauman's body back to the family.

I initially had my body camera on for the notification [REDACTED] [REDACTED]
