On 01/12/2022 at approximately 1755 hours I spoke with [REDACTED] via phone in reference to an identity theft report. [REDACTED] stated that he has been receiving notifications over the past week that various accounts had been opened in his name and an unemployment claim had also been attempted in his name.

On January 5th or 6th of 2022 he received a notification from Life Lock that someone had attempted to open a credit card in his name. He contacted Life Lock and they were able to have the card canceled. Between that occurrence and today he received a letter from Merrill Lynch which thanked him for opening his new IRA and CMA account. He did not open these accounts and contacted Merrill Lynch. The Merrill Lynch representative advised him the accounts were opened with a link to his Bank of America account. [REDACTED] then contacted Bank of America who opened an investigation and put alerts on the account to prevent further suspicious activity. Today he received a letter in the mail from the unemployment office detailing the benefits he would receive should his claim be accepted. Again [REDACTED] did not attempt to perform this transaction and he is employed. The transactions with Merrill Lynch and the unemployment claim were both filed online. [REDACTED] was not deprived of any money as a result of any of the fraudulent activity.

[REDACTED] was unable to provide any further details into any of the fraudulent transactions. I advised [REDACTED] of his right to be entered into NCIC as the victim of identity theft. He is going to research the program on his own and advise if he wishes to take part in it. He was advised to contact police if any further information becomes available.

On 01/08/22 at approximately 1150 hours I was on patrol in vehicle #39 in the area of Peter Place and Preston St when I observed a black sedan bearing NJ registration [REDACTED] parked facing the wrong direction on Peter Place in violation of (39:4-135). After running the NJ registration through DMV it was determined the vehicle's registration expired 12/31/21 in violation of (39:3-4). Since the vehicle was unregistered parked on a township road I contacted dispatch to start a tow truck to impound the vehicle.

Once Sandy's arrived to take possession of the vehicle, The registered owner Robert Nazare exited [REDACTED] Peter Place questioning why his vehicle was being towed. Since this agency is familiar with Nazare I had dispatch run Nazare for any wants/warrants. Nazare was showing a warrant (#E21 5328) for failure to appear out of Toms River, NJ. Once Dispatch confirmed the warrant I approached Nazare and told him he was under arrest and that his vehicle was being towed for not being registered. I had Nazare turn around and place his hands behind his back where he was handcuffed per departmental policy. I escorted Nazare to the rear of vehicle #39 where he was searched incident to arrest prior to being placed into the rear of vehicle #39. I transported Nazare to Brick Police Headquarters where he was processed per departmental policy on warrant # E21 5328.

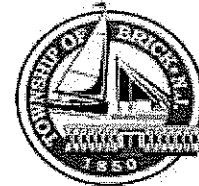
I contacted Toms River Police Department and was advised they would be sending an Officer to pick up Nazare on the warrant out of their jurisdiction. At 1359 hours Toms River Pd responded and took custody of Nazare without incident.

The rear of patrol vehicle #39 was check before and after transporting Nazare with negative results.

On Monday 1/17/22, at 1011 hours, [REDACTED] contacted Brick Police to file a harassment report. [REDACTED] stated he was being harassed by his wife's step father, [REDACTED]. I contacted [REDACTED] by telephone to complete the report.

[REDACTED] reported that he has received several harassing phone messages and text messages from [REDACTED] after they had a phone conversation on Friday 1/14/22. [REDACTED] stated he was speaking to [REDACTED] about financial difficulties he was having. He explained to [REDACTED] that he was planning on turning in his vehicle because he couldn't afford it. [REDACTED] stated [REDACTED] offered to provide [REDACTED] six hundred dollars a month to help with his expenses. [REDACTED] stated he was appreciative, but he believed [REDACTED] was intoxicated and under the influence of prescription pills when he made the offer. [REDACTED] further reported that over the next day, [REDACTED] called him once to say he could only afford five hundred a month to help him. Then, [REDACTED] called him again on Saturday 1/15/22 to say he could only afford to give [REDACTED] four hundred dollars a month. Next, [REDACTED] stated [REDACTED] called him on Saturday 1/15/22 and told him that he could only afford to give him two hundred dollars a month to help him because he needed the other money to pay for sex.

[REDACTED] further reported that he and [REDACTED] had words with each other over the phone and that's when [REDACTED] began receiving text messages from [REDACTED] accusing him of cheating on his wife. [REDACTED] further stated that [REDACTED] began texting his wife and telling her that [REDACTED] was cheating on her.

[REDACTED] stated he and his wife have since blocked both of [REDACTED]'s phone numbers to avoid further harassing calls and texts.

[REDACTED] further stated he is concerned about what [REDACTED] may do because of his habitual drug and alcohol intake. [REDACTED] stated [REDACTED] drinks, uses pills, and then becomes agitated.

[REDACTED] wanted the incident documented in the event the harassment continues.
