On 1/1/2021 at approximately 2203 hours Ptl. Byers #226, Ptl. Dinnebeil #268, and I (Ptl. Marmer #304) responded to 1613 Route 88 for a report of 3 juvenile subjects inside an abandoned building. The caller advised he had two juvenile's detained outside the building and one had taken off running.

Upon our arrival I was met by the caller, later identified as [REDACTED]. [REDACTED] advised he observed the four juvenile subjects looking into the abandoned building of 1613 Route 88 which was currently undergoing construction. He advised he believed they were trying to make entry into the building. [REDACTED] advised he had been the victim of multiple thefts that occurred to property in the front yard of his residence. He advised when he observed the four juveniles looking into the building of 1613 Route 88 he approached them in effort to stop them. He advised two remained on scene and complied when he told them to stop and stated two had fled the scene running. He then called 911 and awaited police arrival. [REDACTED] stated he did not observe the juvenile's inside the building and did not observe any criminal offense take place. He advised he believed the incident to be suspicious due to the juveniles being outside on bicycles in the pouring rain.

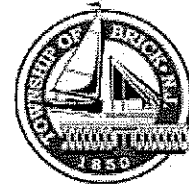
At the time officers were on scene only three Juveniles were present. I spoke with each of the three Juveniles and they had advised they were staying at one of the Juvenile's house down the street, later identified as [REDACTED]'s parent's residence of [REDACTED] Harvard Avenue. They advised they were getting out of the house and planning to go to Walmart. They advised they stopped at 1613 Route 88 because one of the Juvenile's bicycle's broke and they were attempting to fix the bicycle. They advised they were confronted by [REDACTED] when two of the three juvenile's fled the scene. The two juveniles that fled the scene were identified as [REDACTED] and [REDACTED].

They advised they fled when [REDACTED] approached them because they were scared but had no reason to run. They stated they both came back shortly after. All three juveniles were instructed to contact their guardians to come pick them up and notify them of the incident due to the juveniles being in violation of the township curfew which is at 2200 hours.

The parent's of the juvenile's were contacted and advised of the incident. The parents of the juveniles arrived on scene and took custody of the juveniles.

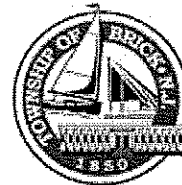

On 05/04/20 at 1047 hrs. I, Ptl. Sean D. Flynn #236, was dispatched to call [REDACTED] in reference to a theft report. Upon speaking with [REDACTED] he stated that in June of 2019 he entered into a business relationship and invested into a company called Creative Crust Inc. with Marc Eric Wexler [REDACTED] creating a Cauliflower pizza crust.

[REDACTED] advised that he invested \$100,000.00, three(3) checks for \$25,000.00 and one(1) cash note for \$25,000.00, into the Creative Crust Inc. company. [REDACTED] stated that the money invested into Creative Crust Inc. also gave him 25% stock into the company. A \$25,000.00 loan was also part of the business agreement.

[REDACTED] stated that Wexler sent him a check for \$25,000.00 for reimbursement of the loan but the check would not clear for insufficient funds. [REDACTED] advised that he held onto the check and attempted to cash it again unsuccessfully. [REDACTED] accountant advised him that his stock shares in the company were only 7.5% not 25%. [REDACTED] believes that Wexler sold off 17.5% of his company stocks as well.

[REDACTED] advised that he has retained a law firm for this situation and the law firm told him to file a police report for the case. [REDACTED] advised that he is in Florida and will not return to New Jersey until approximately June due to the COVID-19 pandemic. No further information to report at this time.
