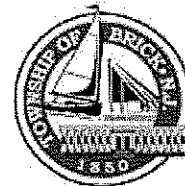

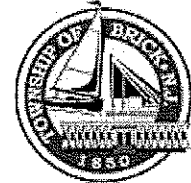

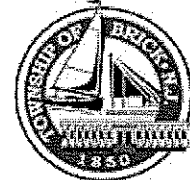

On 10/03/2019 at approximately 0402 hours, Ptl. Catalina #263 and I were dispatched to 1617 Route 88, Laurelton Medical Center, in reference to a smoke alarm activation. Laurelton Fire Company, Herbertsville Fire Company, Breton Woods Fire Company, Point Pleasant Fire Company, Brick Police EMS, and BTFD Fire Bureau Inspectors also responded.

Upon my arrival, I observed light smoke coming from ventilation on the roof as well as several windows on the second story.

Fire personnel entered through the main entrance and advised that a small working fire was located, possibly originating from the microwave or water cooler in an upstairs Allstate Insurance Group office. The fire was extinguished without incident and BTPD Identification Bureau Det. Lash #159 to document. BTFD Fire Inspectors remained on scene to conduct an investigation. Initially, the cause of the fire was not deemed to be suspicious.

Additionally, contact was not made with an emergency contact, and a voice message was left for the building manager to respond. The remainder of the building was checked and ventilated due to the smoke condition.

Dispatch soon upgraded this to a possible structure fire due to police reporting smoke coming from the building. Upon arrival a light smoke condition was seen coming from the eaves of the structure. Entry was made and a fire was located in Unit #204. Fire department started suppression operations. Search of the building for occupants was negative. Ventilation and overhaul was completed, fire was contained to the room of suspected origin, with some smoke and water damage to the adjacent units. Scene was TOT the Brick Township Fire Bureau for further investigation. Power was secured by shutting the main at the panel, NJNG secured the service to the building. NFA #2300

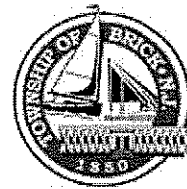

On 1/24/2018 at 2209 hours I was dispatched to the Office of Doctor Sanjay Sikand(1613 Route 88) in reference to a former employee who fraudulently obtained a prescription.

Upon arrival I met with a closing employee who placed me in contact, via phone, with Office Manager [REDACTED]. Press stated that she received a call from Pharmacist [REDACTED] (Rite Aid Route 37 E Toms River) at approximately 1700 hours. [REDACTED] stated that a prescription was called in by [REDACTED] for Ultracet on 1/24/2018. At the time the prescription was called in, [REDACTED] was an employee of Dr. Sikand. When the prescription was picked up [REDACTED] recognized the voice of the person retrieving the pills as the same person who called it in. The person picking up the prescription was identified as [REDACTED] through her driver's license. [REDACTED] took an interest in this particular prescription because he went to high school with the subject it was called in for. Based on these circumstances [REDACTED] felt uneasy about the incident and contacted Dr. Sikand's office to confirm the validity. [REDACTED] was unable to provide the name of [REDACTED] boyfriend at this time but stated she would be able to retrieve it from [REDACTED] during business hours on 01/25/2018.

[REDACTED] researched the incident and found that [REDACTED] boyfriend had never been a patient of Dr. Sikand and therefore no prescriptions were ever authorized for him. At this time [REDACTED] called [REDACTED] and informed her that she was being terminated for calling in the fraudulent prescription. Press stated that [REDACTED] did not confirm or deny calling in the prescription. She added that [REDACTED] did not argue with her and accepted her termination.

[REDACTED] will be contacting the state on 01/25/2018 to see if any other fraudulent prescriptions have been called in prior to this incident.
