On 10/18/2011 at 1617 hours I was dispatched to 1619 West Princeton Ave. for a report of criminal mischief. Upon my arrival I spoke with the caller (victim), Dina Cruz.

Cruz advised on 10/16/2011 between 1900 hours and 0800 hours on 10/17/2011 an unknown subject(s) threw eggs at her house and vehicles. I observed three splatters of egg residue on the front of the house and an additional two egg splatters on the side of the house.

On 8/6/11 at 0937 hrs, I responded to 1619 West Princeton Avenue reference to a criminal mischief report. Upon arrival, I met with [REDACTED] who reported that unknown suspect(s) vandalized her vehicle sometime between 2100 hrs on 8/5/11 and 0800 hrs on 8/6/11. The vandalism consisted of the suspect(s) throwing a six pack of soda cans, several cups of chocolate pudding, and a can of sardines at the house. No damage occurred to the residence however, the victim's vehicle (a white 2007 Ford Explorer, NJ Reg: YPM18R) was parked in the driveway and suffered a dent on the driver's side front door.

According to Cruz, this was the third incident in the last month. Cruz reported no known problems with anyone at the time of this report. Due to the number of incidents, I retrieved two of the soda cans that were undisturbed from the scene. The cans were placed into property at HQ for later processing to see if any latent fingerprints might be recovered. Cruz was advised to contact police if further acts occur.
