because it fails to specifically identify the documents sought, then that request is not "encompassed" by OPRA. See **New Jersey Builders Association v. New Jersey Council on Affordable Housing, 390 N.J.Super. 166, 180 (App. Div. 2007)**. A proper request under OPRA must identify with reasonable clarity those documents that are desired, and a party cannot satisfy this requirement by simply requesting all of an agency's documents. See **Bent v. Stafford Police Department, 381 N.J.Super. 30, 37 (App. Div. 2005)**. Custodians are not required to conduct research or create new records in response to an OPRA request.
