Bonilla by contacting Central Communications to enter a NJ Firearms Purchaser Card [REDACTED] as stolen into NCIC. The NJ Firearms Purchaser Card was entered into NCIC at 2224 hours, with the entry number of 18-0282. End of report.
01/26/2018 11:37	On Thursday 1/25/18 at 1456 hours, Steven D. Chrzanowski came to Lindenwold Police Headquarters (Lindenwold, NJ) to report a vehicle burglary. In summary, Steven explained that the following incident occurred. Steven stated that between 1/22/18 at 2000 hours and 1/23/18 at 0730 hours, an unknown actor(s) entered his vehicle (NJ Reg: D72 DJV). Steven stated that his vehicle was unlocked in his driveway. Steven noticed that someone entered his vehicle because multiple items were missing and multiple items were moved from their original place. Steven indicated that the following items were stolen. A Discover credit card (\$1), Capital One credit card (\$1), his NJ Firearms Purchaser Identification Card (\$5), and five dollars in coins. I checked with our clerks (Lindenwold Police Clerks) and they informed me that Steven was in fact issued a NJ Firearms Purchaser Card [REDACTED] by Lindenwold Police Department. According to Steven, these stolen items were between the front driver/passenger seat. I asked Steven if he had called the credit card companies to see if the credit cards were used somewhere and he replied that he did call to cancel them. Steven was also informed that the credit cards were not used to purchase anything after they were stolen. Steven stated that he does not have surveillance cameras. He also said that there were no witnesses to the incident. When I asked him if he had any suspects to name or any enemies, he replied, "No". There was no evidence collected. Ptlm. Maldonado entered the NJ Firearms Purchaser Identification Card as stolen (see his supplemental report for further details).

12/07/2020 16:29	On Monday, December 7, 2020 at approximately 1353 hours, I responded to Cooper Hospital in Camden, NJ in order to take possession of a bullet fragment that was removed from a patient, Steven Chrzanowski, who shot himself accidentally in the thigh. I met with Lt. Santos, the head of security at Cooper Hospital's security control center. Lt. Santos released the bullet fragment to me and I submitted the same as evidence.
12/06/2020 15:56	On 12/06/20 at 1429 hours Lindenwold Police were dispatched to 511 Chestnut Street for a report of a shooting incident. It was reported that the victim, Steven D Chrzanowski, shot himself in the leg by accident while attempting to work on his pistol. The caller, Lynn Mangano, said that Steven did not have the weapon in his possession and it was on the table. Upon arrival Steven was sitting on the living room couch with a blanket wrapped around his leg. The weapon was secured and EMS was advised to come inside to render aid. At this time I cleared the rest of the residence with no contact with anyone else. Lynn was unharmed and said that she did not witness the incident but heard the shot. Lynn was in another room caring for her cats when she heard the shot go off and then Steven screamed he shot himself. Steven said he was attempting to upgrade the trigger on his firearm and did not properly clear and make the weapon safe when a single shot went off and struck him in the left thigh with no exit wound. EMS was able to stabilize Steven and take him out on a portable stretcher. Steven was loaded onto the ambulance and transported to Cooper Hospital in Camden, NJ. The weapon was taken as evidence and entered into safekeeping. A check through NCIC revealed that the weapon did not have any wants or warrants. Steven was told to retrieve the weapon at a later date at police HQ. Police units then cleared the scene without further incident.

09/29/2023 00:01	On September 28, 2023 at 1812 hours, I responded to LPD HQ for a walk-in to report cyber harassment. I spoke with the victim, Lynda Mangano, who stated that she has been getting cyber harassed for a few weeks now, due to the Evesham PD case involving the death of at least 30 dogs in a house on the 600 block of Main Street in Marlton. Lynda stated that she and the suspect of that case, Rebecca Halbach, had partnered previously in Lynda's animal rescue foundation. Lynda stated Rebecca had been using her foundation's information without her knowledge and that she was unaware of Rebecca's involvement in the Evesham case. Due to this, there have been three female suspects, Kelli Bowen, Janice Thompson, and Lori Genstein, who have been harassing Lynda via social media. The three suspects were identified because Lynda provided first and last names, addresses, telephone numbers, and partial birthdays. All three suspects were properly identified, for possible future harassment complaints, and one of the suspects, Kelli, was contacted on 9/13/23 and advised to stop harassing Lynda (#2023-15193). Lynda provided multiple screenshots of posts and comments that Kelli, Janice, and Lori posted or were a part of, which were submitted to the case. I advised Lynda that I would review all of the documents and contact her, via telephone, with my findings. Due to another case, I was unable to call Lynda, but will follow up with her tomorrow, in reference to complaints. I also requested to speak with Evesham PD in reference to their case, but Det. Magnus was unavailable at this time, due to him being off. I spoke with Det. Gates, and she advised that she would have Det. Magnus reach out to me tomorrow. On September 29, 2023 at approximately 1800 hours, I spoke with Lynda, via telephone, and advised her that she could come to the station to sign a complaint of harassment against Kelli, Janice, and Lori at her earliest convenience. Lynda stated that she would sign the complaints at a later date. As of 2100 hours, I have been unable to make contact with Det. Magnus. Uploaded into Evidence.com BWC
