WHEREAS, the Township Chief Financial Officer has certified that funds are available in account T-16-56-100-002.

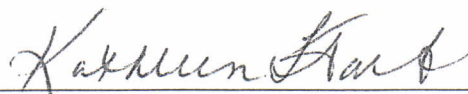

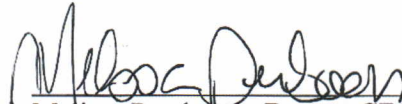
