On May 28, 2024, at approximately 1447 hours, I was advised by Lt. Beckett #2304 to speak with Joseph Vitale at his residence regarding an ongoing issue he is having on Facebook and report of someone trespassing on his property. Upon arrival, I met with Vitale at his front door. Vitale wished for me to speak with him inside of his residence and requested my body worn camera (BWC) be shut off to prevent anyone who views the BWC footage to see inside of his home. I advised Vitale I would need to contact a supervisor to determine if I could shut off my BWC. On scene, I spoke with Lt. Beckett via cell phone and advised him of Vitale's wishes. Lt. Beckett advised that due to Vitale being a possible victim in this case that I could shut off my BWC.

I advised Vitale that I was approved to shut off my BWC and spoke with him inside of his residence. Vitale explained on going online harassment against him regarding his political campaign for Mayor of South Harrison Township. Vitale stated he believes the same people from prior incidents he has been involved in are the people posting about him. Vitale has screenshots of the harassing Facebook posts made by an anonymous member. I advised Vitale to email me the screenshots to further review them and have them on record.

Vitale was advised that we could not prevent the posting on social media, but it would be documented.

Vitale also advised me of a possible trespassing that occurred over the weekend. Vitale stated that he has, Brian Budd, a nearby neighbor on video trespassing by his property line. While on scene, I observed the video footage and could not determine if he crossed the property line. I advised Vitale to email me the footage to further review it.

Vitale was advised on scene to email me the further information needed to complete the report including timelines of the possible trespassing, video footage and screenshots of the anonymous Facebook posts made about him.

At this time there is nothing further, awaiting further information from the complainant.

The posts reference previous allegations and incidents related to an ongoing neighbor dispute involving multiple parties.

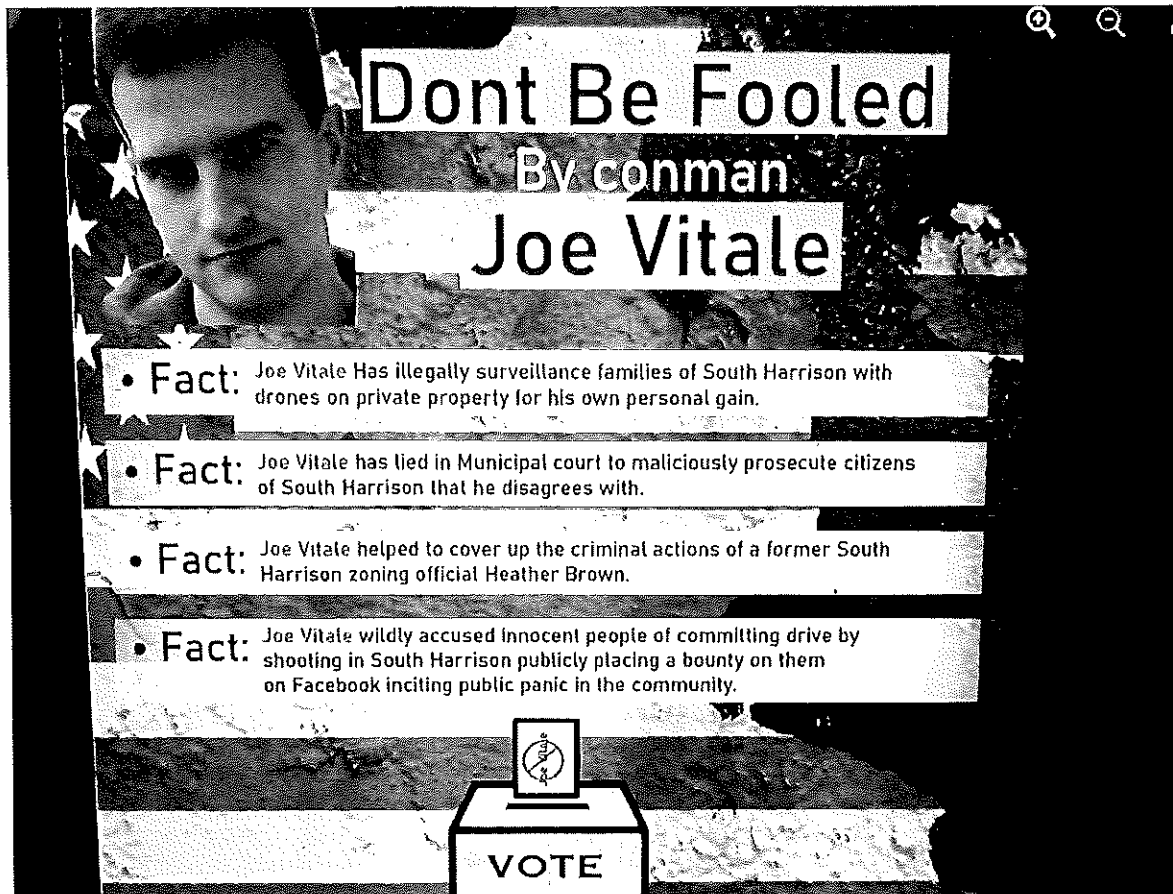

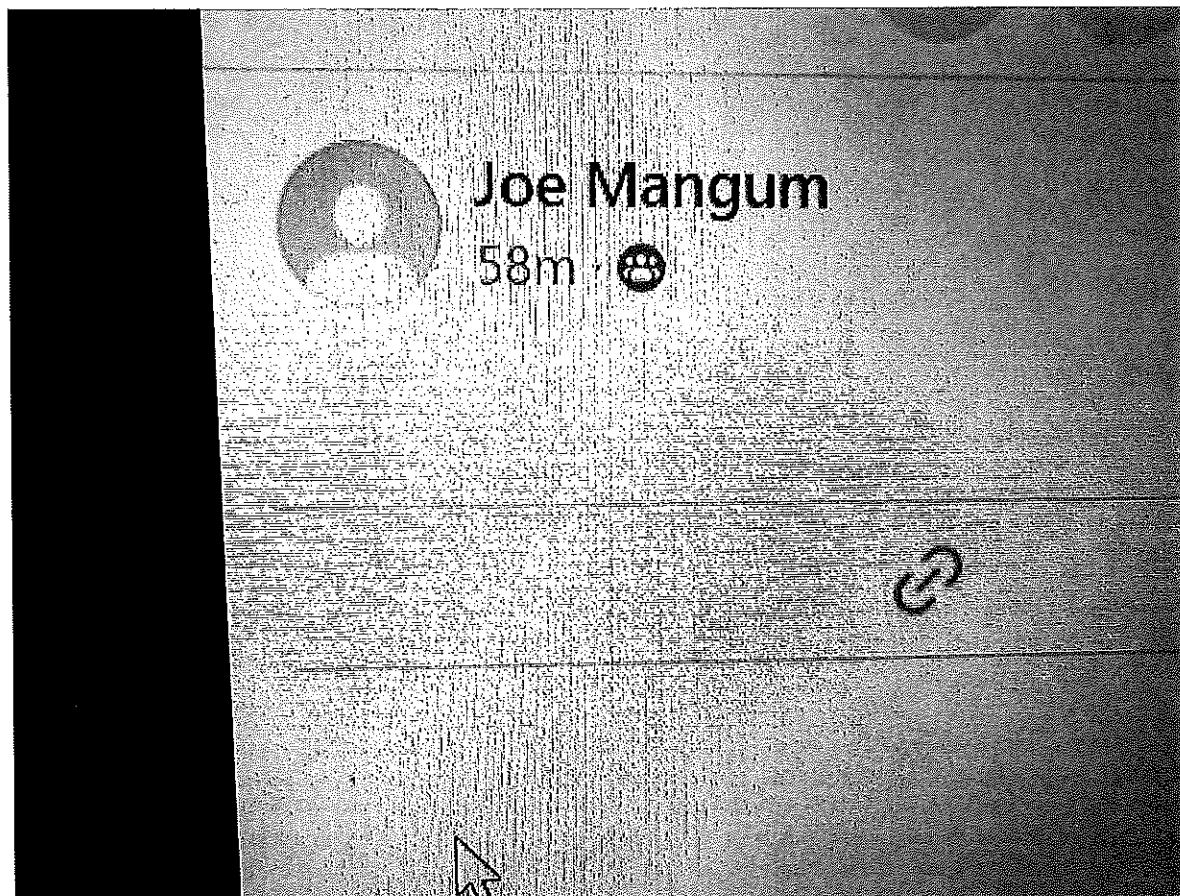

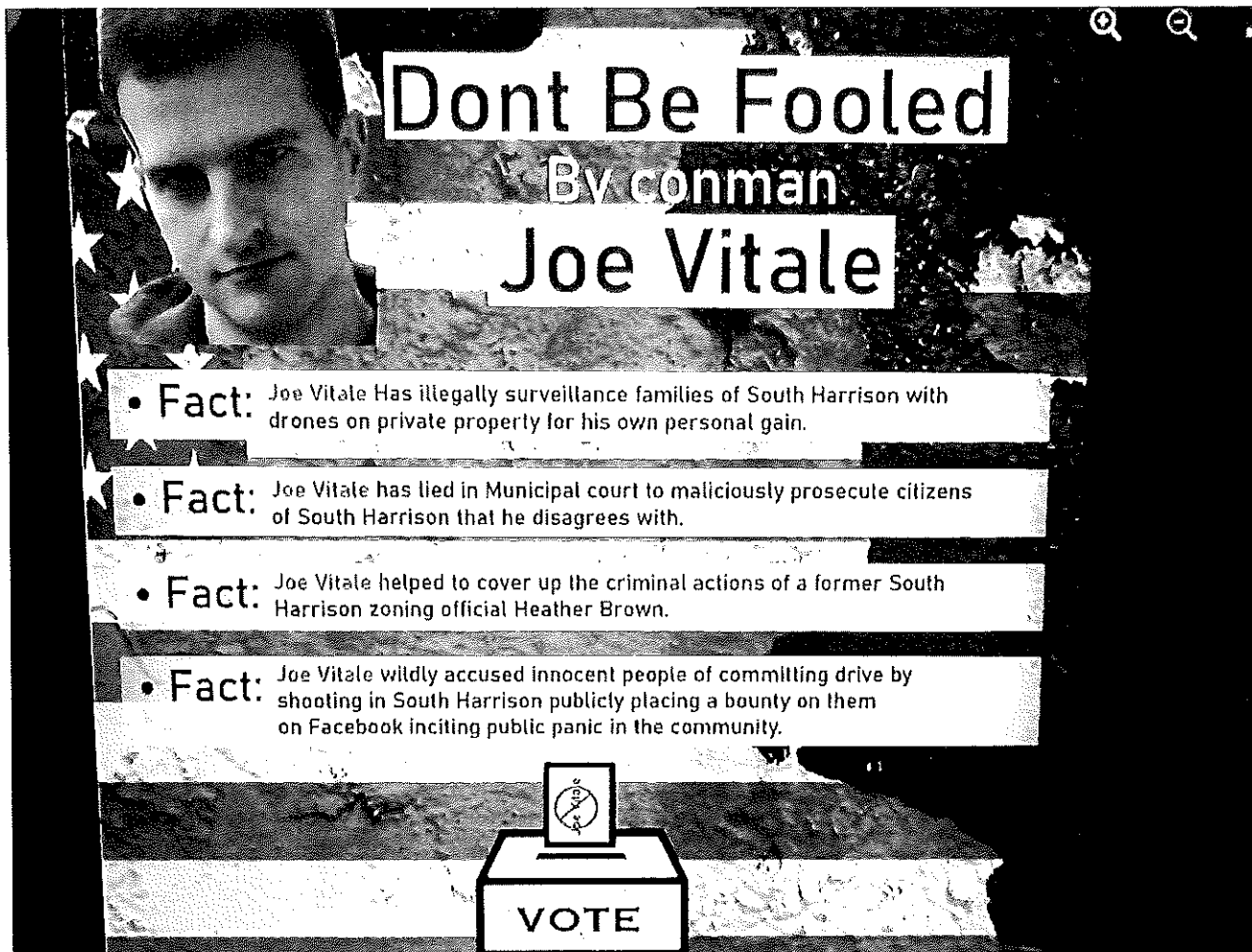

As a reminder, I am a witness in multiple criminal cases against the person(s) who made this and this may be the most blatant form of intimidation I've seen so far.

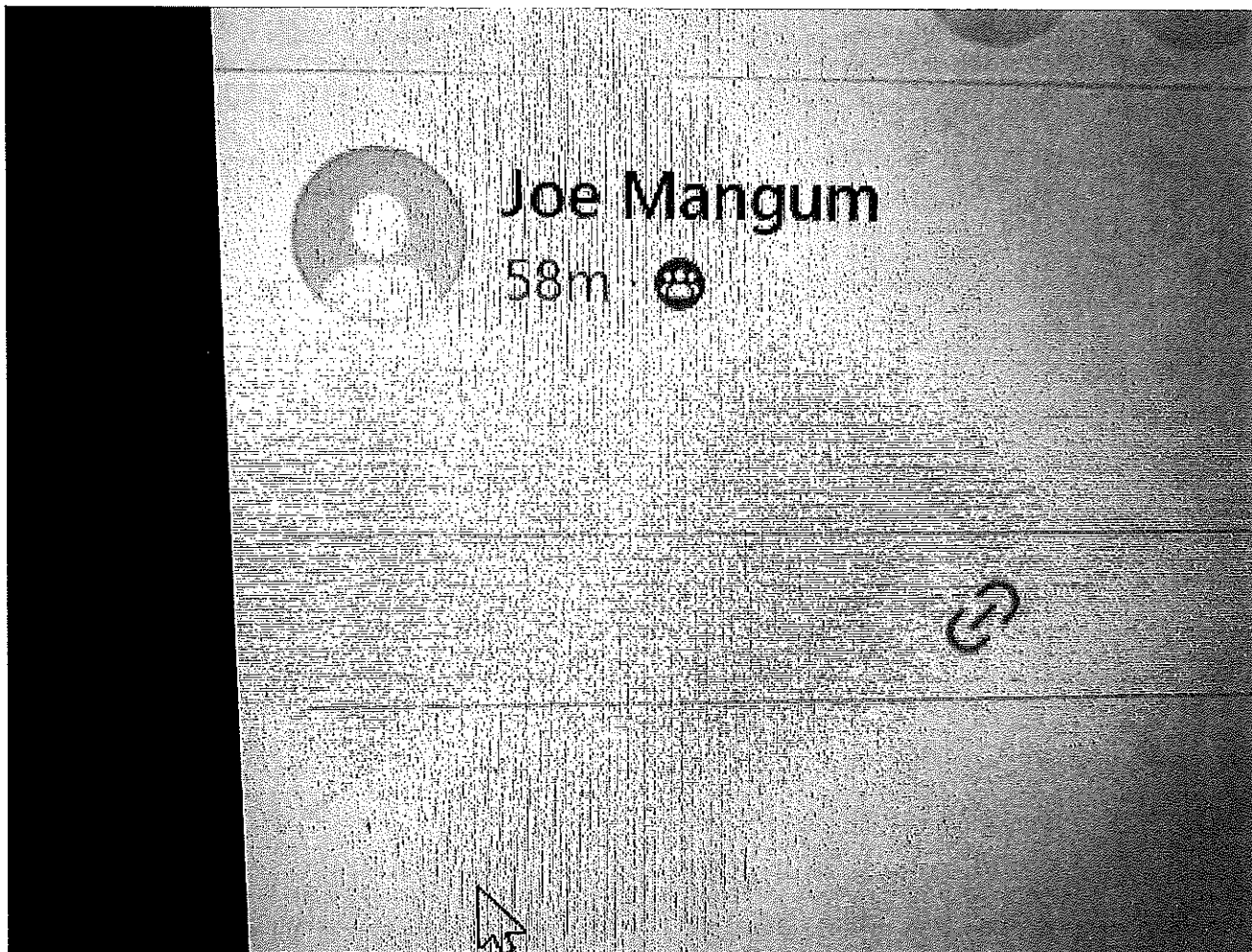

This evening, an anonymous user who I believe to be Brian Budd, who I am a witness in a criminal case against for a firearm charge, or Richard Hanratty, has posted to Facebook what appears to be a false or incorrect police report and tagged me. This police report appears to indicate that I was charged with criminal mischief, although I was not (I wasn't home at the time of the incident and was a victim of an unsolved crime that evening), and these individuals are very aware of that fact. In 2020, I brought this to the attention of the department.

This was posted to the South Harrison Township Talk page. (See attached)

The anonymous poster(s), along with Dana Durso and Richard Hanratty have been repeatedly and knowingly posting false statements about me. For example, Mrs. Durso is repeatedly falsely stating that I called 911 on my neighbors over 50 times - your department can confirm in your records that that I have called 911 on my neighbors a total of zero times. They're using the election as a platform to continuously harass me in a public forum, and using this police report as "proof" that I did something wrong.

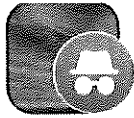
What is more concerning to me than the fact that they are harassing me for the past 72 hours non-stop, is that the Woolwich Police Department would release a document with this information in this format, especially before an election.

At this point, I'm not exactly sure what to do as I'm starting to feel a little unsafe living across from these people. Responding to them doesn't work, ignoring them doesn't work. As you know the last time they posted my address and accused me of false crimes, someone came into my yard and vandalized my property.

What line do they have to cross for something to be done about this?

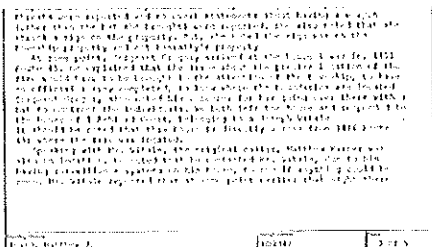

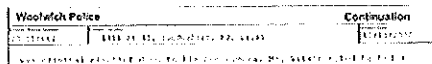

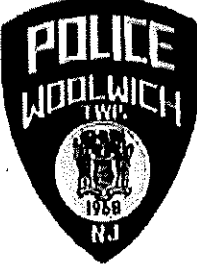

About ten minutes ago, I was driving down Marl Road approaching Eldridge's. There was a jogger, heading in the same direction, this jogger turned out to be Brian Budd, I did not know he was there or that it was him until I was about to pass him, when he stopped jogging, pulled out his phone and appeared to be recording and approaching my vehicle, while appearing to be narrating the video. I did not make eye contact or interact with him in any way. I then drove off onto the grass on the opposite side of the road (Petit side) to create as much distance as possible between he and I. As I continued to drive away he continued to record.

Given that we live directly across from one another, I understand that we will obviously end up in the same place at the same time. I am only sending you this because for the last 2 days an anonymous user on Facebook, who I believe to be Brian Budd has been slandering me, using the election as a platform to do so. I do not know what his intentions are with the video. He has also made numerous record requests looking for any "dirt" he can use to bash me on Facebook. These requests are being made using opramachine, one as recent as 3 days ago (screen grab previously sent). The account has made requests for documents pertaining to his business, Powerwashing Pro, so it is reasonable to assume he is the owner of the "anonymously" account on opramachine.

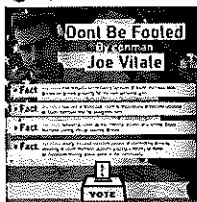

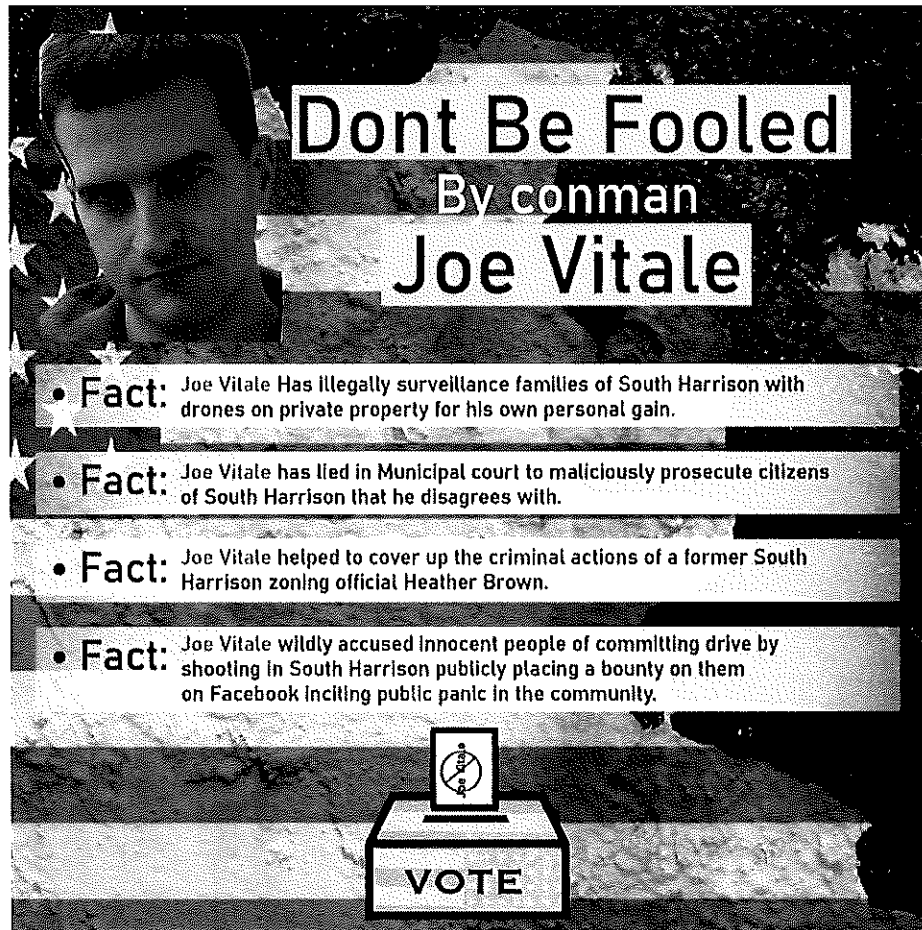

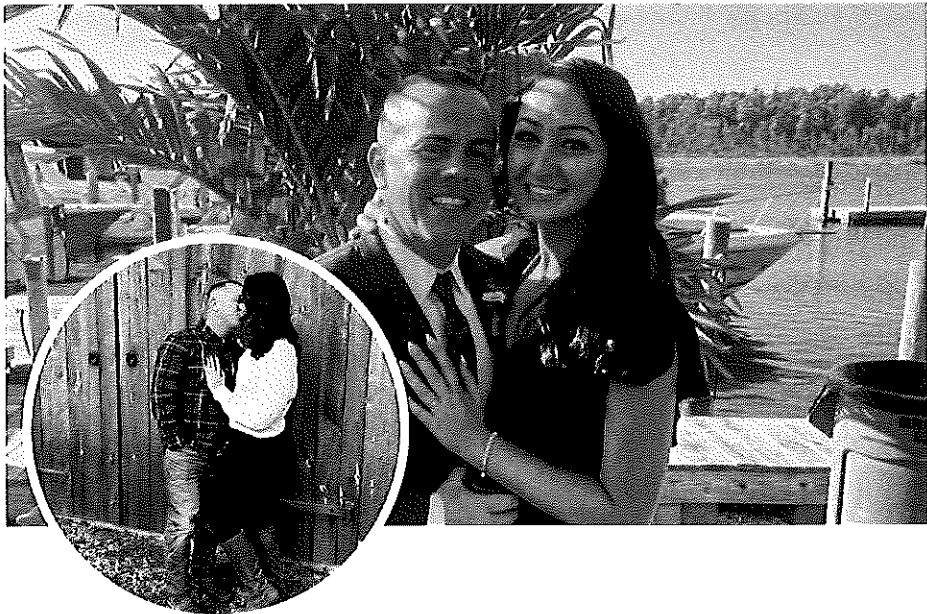

I would like to add that yesterday Mr. Budd has made a record request seeking information about me with the township I used to live in, dating back 20+ years. This is a continuation of the constant stalking which has been increasing in frequency over the past months. He is often in my yard taking photos (or at least appears to be), all while telling the court he is afraid of me and asking for a "no contact".

Brian doesn't use the official OPRA form because there's a question on it about whether you have been convicted of a felony. Instead he uses an online service called opramachine which posts the results publicly. You can have a look and see that they have made wildly false claims about Heather brown in their searches, which makes those false claims public and searchable. In itself that behavior is, in my opinion, cyber harassment.

If this isn't harassment, I don't know what is. They're using the same pseudonym as the return address on the letter about Matt Warner a few years ago. No surprise there.

This poster was posted to one of the south harrison pages. Pretty obvious who it is, not sure what can be done about it. Just sending it to you in case anything else happens there's a paper trail.

And these people wonder why I have security cameras.

As a reminder, I am a witness in multiple criminal cases against the person(s) who made this and this may be the most blatant form of intimidation I've seen so far.
