Good day,

The Ocean County Sheriff's Office received your Open Public Records Act (OPRA) request on or about May 6, 2018. The official Records Custodian, Lt. Joseph Greene, received your OPRA request on May 7, 2018. As such, the seven (7) business day deadline to respond to your request is May 15, 2018. This response to your request is being provided to you on the 1st business day after the custodian's receipt of said request.

The following records were requested:

1. "I would like the CAD information, 911 audio, Spillman Data, and other reports regarding the Ocean County Sheriff's response to the 200 block of Hamilton in Seaside Heights on 05/06/2018 in the early morning."

This request is an ongoing investigation by the Ocean County Sheriff's Office and the Ocean County Prosecutor's Office. As such your request for records is denied under NJSA 47:1A-1.1(4).

4) Criminal investigatory records - records which are not required by law to be made, maintained or kept on file that are held by a law enforcement agency which pertain to any criminal investigation or related civil enforcement proceeding. (Note: N.J.S.A. 47:1A-3.b. lists specific criminal investigatory information which must be disclosed).

Please contact the Ocean County Prosecutor's Office directly to ascertain the availability of the request.

This response is being communicated with you via e-mail at your request.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Ocean County Sheriff's Office to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.

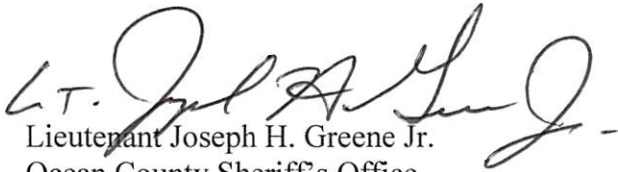
