OPRA does not outline any requirements. Your conviction status is irrelevant for almost every request. The only time it becomes relevant is where someone seeks records to get the personal info of their own victim (but again, OPRA does not outline any procedure for how to implement this procedure)

47:1A-2.2. Access to public records by inmates; victim's personal identifying information

Currentness

a. Notwithstanding the provisions of P.L.1963, c. 73 (C.47:1A-1 et seq.) or the provisions of any other law to the contrary, where it shall appear that a person who is convicted of any indictable offense under the laws of this State, any other state or the United States is seeking government records containing personal information pertaining to the person's victim or the victim's family, including but not limited to a victim's home address, home telephone number, work or school address, work telephone number, social security account number, medical history or any other identifying information, the right of access provided for in P.L.1963, c. 73 (C.47:1A-1 et seq.) as amended and supplemented shall be denied.

b. A government record containing personal identifying information which is protected under the provisions of this section may be released only if the information is necessary to assist in the defense of the requestor. A determination that the information is necessary to assist in the requestor's defense shall be made by the court upon motion by the requestor or his representative.

c. Notwithstanding the provisions of P.L.1963, c. 73 (C.47:1A-1 et seq.) as amended and supplemented, or any other law to the contrary, a custodian shall not comply with an anonymous request for a government record which is protected under the provisions of this section.

Investigator Burness,

I spoke with the zoning officer yesterday, he told me that he has issued another round of zoning code violations to the properties involved with the illegal dirt bike race track.

As a Fuck You, they rode the balls off their bikes all evening.

As far as I can tell, nobody called the police to report it, because nobody wanted to deal with the harassment and retaliation. I'm sure we will have another opportunity today. For years, anyone who complains about the bikes will be harassed in return. They already made one family move out (See Police Report 20-004612 - attached) - they listed their house a month later. They've been harassing me since June of 2020, and the more I would complain, the worse it would get. They called your officers to their house on 6/29/2022 and asked them to intimidate an elderly woman, and threaten to "charge her" because they don't like her nature camera because it picks up the sounds of their dirt bikes - think about how twisted that is. Honestly, the worst part is that the officer entertained the idea, went to her door and luckily she wasn't home - you can watch the BWC and see for yourself.

And, as you know, now they're requesting police reports with my personal information and having them posted online. I'm sure I'll be reading this email soon enough on opramachine.com with my email address unredacted. Dana Durso continues to tell everyone in this township that I "stalk children" (see attached). Her and her husband also yell "pussy", "faggot", "loser", "cunt" etc. when they see me walk down Marl Road (a public road). I challenge you to find any evidence of me harassing someone while they walk in front of my house, which they do often. Budd was in my driveway 14 times the other night "jogging". Just 2 nights before he was due in court - and didn't show up, and wound up with a bench warrant. Of all the driveways to decide to turn around in, he chose mine. Did I harass him? No. I never do. Dana Durso and Brooke Budd walk on my lawn with their kids (which is crazy considering I'm a "child stalker").

The funny thing is they'll tell you (as they have many times) that they're being "harrassed" by everything from driving down a public road, to taking too long to make a left into Ashford Ct. They've now named 13 people who "harass" them including an elderly farmer who they claim has a secret launch pad for "weaponized" drones that "attack" them. They complained to your department about drones "as heavy as car engines" (it weighs 0.55 lbs) and reported on drones with "handguns" strapped to them, drones that "drop fireworks in camp fires", and drones that watch children piss on bushes. All in some convoluted and

elaborate effort to have me "put in prison". At what point does your department decide that enforcing the ATV or noise ordinance is easier than listening to this go on and on?

I didn't call yesterday because I wanted to send you the ordinance first so you can review it.

What's wrong with the track?

Half of it is on Brian Budd's lot which is less than 2 acres. No riding is allowed on lots less than 2 acres. His lot is also 150' wide so they would always be within 100' of a property line, which is also not allowed.

The other half is within 100' of Frank's property lines. You cannot operate these bikes within 100' of any property line regardless of whether your next door neighbor gives you permission. The whole point of the ordinance is to prevent these tracks in residential areas, and that's exactly what we've got.

Could they legally have a track? Sure, but it would be a tiny little 100x100' track that would be appropriately sized for that lot and wouldn't be conducive to hours upon hours of racing. The entire reason that ordinance was created in the first place.
