The initial hearing was conducted while the inmate was housed in the infirmary. The inmate admitted to hitting inmate [REDACTED] but claimed that [REDACTED] annoyed him when he was blowing kisses at him through the window when he was housed in Booking. The inmate was very apologetic for his actions and claimed that was still high on zanax when he was in booking and didn't really know what he was doing.

The DVR shows the inmate in Booking cell 7, as inmate [REDACTED] (the Trustee) enters the cell to collect the trays, he is struck in the head by inmate Grenci, the officer immediately separates the inmates.

The reports indicate that the inmate Grenci struck [REDACTED] when he was collecting the trays, [REDACTED] was escorted from the Booking cell 7 and both inmates were seen by the nurse who did not observe any serious injury to either inmate.

I found the inmate guilty of the Assault charge based on the reports, the inmates statement and the DVR. There was no serious injury caused by this incident, it is also clear that no further behavior modification is required against this inmate as most of this was caused by his being under the influence of the narcotic.

Leniency was shown, the inmate as given 7 days SH all of which was suspended.
