Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

The victim has been continually harassed by Jennifer Coombs since July 2019 when he moved into his residence. After numerous warnings from multiple Neptune City Police Officers, to avoid contact/harassment of the victim, Coombs behavior continued and escalated. The victim reported Coombs followed him in her vehicle while he walking his dog and drove past him, giving him the finger and yelling "fuck you" to him as she passed. The victim reported Coombs intentionally left a residence across the street for the distinct purpose of following him and harassing him. The victim also heard Coombs tell a resident of 16 Evergreen Ave that the recently installed surveillance cameras would be used to constantly surveil the victim and his family. Due to the multiple documented incidents and their escalation, the victim has become fearful of his safety and the safety of his family over the course of over a year of Coombs erratic behavior.

Although Coombs address of record is 83 Riverdale Ave it is believed by this officer that she either lives or frequently stays at 16 Evergreen Ave, which is across the street from the victims residence.
