On 12/26/2023 at approximately 1930 hours, Ptl. Lestuck and I (Ptl. Mendes) were dispatched to 37 Overhill Dr. for a welfare check. Upon arrival we made contact with the reporting party, Marc Jellinek. Marc began by stating that he was trying to get help for a friend, Rebecca Lynn Puntorno, who is currently homeless and may have been a victim of domestic violence. When asked where Rebecca was, Marc stated that she had just left his house. Marc then stated that Rebecca reached out to him earlier in the day and said she was coming over his house. Marc stated that Rebecca came to his house with another male, possibly called Markies, sometime after 0930 hours. Marc further explained that Rebecca was over his house to get something to eat and to make a plan to help her stop being homeless. Marc further stated that they left his house, with Rebecca and Markies in their own vehicle, and Marc in his vehicle, and they all went to Motel 6 on Rt. 18, East Brunswick. Marc explained that Rebecca and Markies were renting a room at the Motel 6. Marc then explained that he had an encounter with East Brunswick Police Officers who were at the parking lot of the Motel, where he asked the officers how he can get help for Rebecca with her being homeless situation. Marc stated he was not satisfied with the officer's help and left the Motel 6 with Rebecca to go to Shoprite on Rt. 18, shortly after leaving her there

and driving home alone.

Marc then explained that while driving home from ShopRite, he made the call to Sayreville Dispatch non-emergency line to inquire as to how he can help Rebecca since East Brunswick Police couldn't offer a solution. Marc explained to me that he didn't need to police to respond to his house. When I asked about Rebecca's whereabouts, Marc stated that she was supposed to come to come back to his house but had not yet arrived. Marc was advised to call Sayreville PD if Rebecca shows up to his house in need of assistance,
