The time to respond to the request was extended to July 3, 2025. Enclosed please find the records requested. The records have been redacted to protect confidential information as follows:

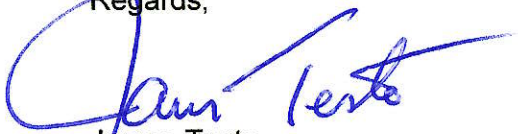
- Board of Education minutes closed session January 28, 2021.
