The Lower Township Police Department received your Open Public Records Act (OPRA) #23-165 request on September 11, 2023.

Your request sought access to:

1. Total number of body cameras currently deployed in the police department.
2. Date on which body cameras were deployed to any of the police officers for the first time (year and month)
3. All invoices of body camera purchases (if body cameras were purchased).
4. Dates of initial body camera assignment for each police officer currently employed.

The response to your request is as follows:

1. 53 AXON body-worn cameras are currently used in our department.
2. Our records indicate the first body-worn cameras were assigned in our department in May of 2017.
3. Any invoices and purchase orders must be requested from the Purchasing department of Lower Township. Your request was forwarded to them upon receipt for their response.
4. All officers hired on or before May of 2017 were assigned a body-worn camera in May of 2017. Any officers hired after May of 2017 were assigned a body-worn camera upon employment with our department.
