Dear T. Kim,

The Town of Secaucus received your Open Public Records Act (OPRA) request on August 31, 2023. As such, the seven (7) business day deadline to respond to your request is September 11, 2023. Please accept this letter in response to your request.

Your OPRA request sought access to the following:

“Records requested:

- 1. Total number of body cameras currently deployed in the police department.**
- 2. Date on which body cameras were deployed to any of the police officers for the first time (year and month).**
- 3. All invoices of body cameras purchases (if body cameras were purchased).**
- 4. Dates of initial body camera assignment for each police officer currently employed.”**

Your request requires additional time beyond the seven (7) business days to fulfill because The Departments are still working on your request. OPRA allows custodians to seek extensions of time pursuant to N.J.S.A. 47:1A-5. i. Specifically, OPRA states that, “the requestor shall be advised by the custodian when the record can be made available. If the record is not made available by that time, access shall be deemed denied.”

Your request requires an extension of time until September 25, 2023.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you have a right to challenge the decision by the Town of Secaucus to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Council (GRC) by completing the Denial

of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
