Re: OPRA Request

Dear Tony Michael,

Pursuant to your OPRA request, HCPO has identified the following records, which are not exempt as criminal investigatory records, N.J.S.A. 47:1A-1, and which will be disclosed to you.

HCPO has confined its response to your request to that concerning OPRA — not the common law right of access. Regardless, access under the common law involves balancing a requestor's interest in obtaining the related record(s) against the State's interest in nondisclosure, see Loigman v. Kimmelman, 102 N.J. 98, 103 (1986), which cannot be accomplished here due to a lack of information.

Your Open Public Records request has been processed in accordance with N.J.S.A. 47:1A-1, et seq. If your request has been denied in whole or in part, the Hunterdon County Prosecutor's Office reserves the right to raise any other grounds for denial not raised in this response. The failure of the Hunterdon County Prosecutor's Office to assert an exception or privilege herein does not act as a waiver of any ground for denial not raised herein.
